Our Financial Year commences on April 1 and ends on March 31 of the following year, so all references to a particular Financial Year are to the twelve-month period ended March 31 of that year. In the Prospectus, discrepancies in any table, graphs or charts between the total and the sums of the amounts listed are due to rounding-off.

There are significant differences between Indian GAAP, IFRS and U.S. GAAP. Our Company has not attempted to explain those differences or quantify their impact on the financial data included herein, and the investors should consult their own advisors regarding such differences and their impact on the financial data. Accordingly, the degree to which the restated financial statements included in the Prospectus will provide meaningful information is entirely dependent on the reader's level of familiarity with Indian accounting practices. Any reliance by persons not familiar with Indian accounting practices on the financial disclosures presented in the Prospectus should accordingly be limited.

A notice under section 138 of the Negotiable Instruments Act dated August 9, 2014 has been sent to Mehar Fitness and Health Zone, Mr. Vishal Verma and Mr. Manvendra Singh Yadav, our Jaipur franchise and its owners for recovery of Rs 6,07,768/- (Rupees Six Lac Seven Thousand Seven Hundred and Sixty Eight Only) due towards outstanding balance and outstanding Franchise Fees and Royalty Fees. We have further sent a Mutual Discussion Notice for resolution of disputes dated August 13, 2014 to mutually arrive at a resolution of disputes/ issues between the Parties. The matter is pending

Litigations involving our Directors / Promoter

A. Against our Directors / Promoter:

a) Legal Notice dated February 07, 2014 from Mr. Dilip P. Bedi

Mr. Dilip P. Bedi, Advocate High court has sent legal notice on behalf of his client Mr. Rajesh Kapoor, Ex-director of SVC Resources Limited to Mr. Akshat Gupta and Mr. Ashok Gupta as directors of SVC Resources Limited for alleged defamation of his client by publishing defamatory and false information about him on BSE website. The notice is given to withdraw the alleged defamatory article and publish apology on the official website of BSE within 15 days of receipt of the legal notice. Mr. Ashok Gupta has replied to above notice vide letter dated February 22, 2014. There is no further correspondence on the matter.

b) C. A. No. 13 of 2014 in C. P. No. 31(MUM) of 2013 before Company Law Board

Mohit Khullar and others have filed an application dated March 18, 2014 before Company Law Board (CLB), New Delhi praying for initiating the contempt proceedings against the SVC Resources Limited, Mr. Ashok Gupta, Mr. Akshat Gupta, Mrs. Sushma Gupta and others for breach of orders of Hon'ble CLB dated January 23, 2014 and that the Observer's Report on the EOGM dated January 11, 2014 may be implemented and the new Board be allowed to take charge of the affairs/ management of the Company. Hon'ble CLB, New Delhi Bench vide order dated April 04, 2014 allowed the C. A. No. 13 of 2014 and directed SVC Resources Limited to implement the resolution passed in EOGM dated January 11, 2014 in toto. The existing board was superseded by the BoD appointed in the EOGM. The matter is pending for final hearing on July 9, 2014.

Meanwhile, Mr. Mohit Khullar and others filed appeal in the Honorable High Court with a prayer to call EOGM as per the requisition notice u/s 169(7) of the Companies Act, 1956 dated April 3, 2013. Pursuant to said appeal the high court passed order on August 14, 2013, August 26, 2013 and September 4, 2013 wherein the Hona High Court has recoded the undertaking given by the then MD Mr. Ashok Gupta that the status quo as of today in respect of shareholding will be maintained until the further order. The statement is accepted as an undertaking given in the court.

The next date of hearing is 12th September, 2014.

c) Company Appeal No. 10 of 2014 before Company Law Board

2. Declare the allotment of 2,97,00,000 equity shares on 05.08.2013 to be irregular and void and cancel the shares allotted as per the said announcement to M/s. Subhtex India Limited.
3. direct rectification of the Register of Members of the Company.
4. direct the old Board of Directors, through Respondent No. 1 (ex-managing Director) to handover the information and documents related to the Company to new Managing Director of the Company.
5. to stop the 3 directors viz. Ms. Neha Kiran Gandhi, Mr. Divesh Kohli and Mrs. Shrishti Suresh Deora from holding any meeting and giving any outcome until their appointment is confirmed by the members.

Applicants have also seek Interim Reliefs as under:

1. Restrain respondents and promoters from investing, selling, disposing off, encumbering or alienating any of the shares allotted as per announcements dated 08.05.2013 and 05.08.2013.

2. Direct the ROC, Mumbai to upload names of new Board of Directors in place of existing directors in compliance with order dated 04.04.2014 of the CLB, Principal Bench, New Delhi.

The next date of hearing is 12th September, 2014.

Meanwhile SVC Resources Limited and Mr. Mohammed Ali, Managing Director of SVC Resources Limited, have filed C. A. No. 130 of 2014 in Company Appeal No. 10 of 2014 before Company Law Board, Mumbai to transfer the above Company petition to CLB, New Delhi Bench as another Company Petition being C. P. No. 31 of 2013 is pending before that bench for hearing and disposal.

d) Complaint against Akshat Ashok Gupta in the C.C. No. 1001434/PS of 2012

Juhu Police station has registered a FIR no. 3197 for offence under Section 185 of Motor Vehicle Act bearing C.C. No. 1001434/PS of 2012 against Akshat Ashok Gupta in 10th Court of Metropolitan Magistrate, Mumbai.

The case is compounded and disposed off by the court.

e) Complaint under Section 138 of the Negotiable Instruments Act bearing C.C. No. 37/2013

M/s. Prudent Fintrade Pvt. Ltd. had filed a Complaint under Section 138 of the Negotiable Instruments Act bearing C.C. No. 37/2013 against Mr. Akshat Ashok Gupta for cheque bouncing. Both the parties have filed a compromise before the Hon'ble Metropolitan Magistrate Court no. 33 of Ahmedabad in the C.C. No. 37/2013 and agreed to settle the dispute out of the Court for full and final settlement amount of Rs.24,50,000/-. As per the terms of settlement, Mr. Akshat Ashok Gupta has paid Rs.19,00,000 till date.

f) SEBI Notice dated June 02, 2014 to Santowin Corporation limited

SEBI vide notice dated June 02, 2014 under rule 4 of SEBI (Procedure for holding inquiry and imposing penalties by Adjudicating Officer) Rules, 1995 read with section 15I of SEBI Act, 1992 has alleged that Santowin Corporation limited has provided wrong and misleading information to SEBI regarding the disclosure of acquisition of shares of Santowin by one of the promoter of our Company Mr. Akshat Gupta. It was also alleged that Santowin has violated Regulation 13(6) of SEBI (Prohibition of Insider Trading) Regulations, 1992 regarding disclosure of above acquisition to stock exchange i.e. BSE. SEBI has called upon Santowin to show cause why an inquiry should not be held against it for above violations. Santowin has replied to SEBI vide letter dated June 25, 2014. Further MR. Ashok Gupta, Director of Santowin Corporation Limited had attended the SEBI office and seek adjournment and subsequently sent the mail confirmation for adjournment vide email dated August 21, 2014.

The next date of hearing is awaited.

1. Complaint for registering FIR u/s. 156(3) CPC against Pranidhi Commerce Private Limited and others

Mr. Akshat A. Gupta has filed an complaint before the Additional Metropolitan Magistrate Court at Mumbai dated April 09, 2013 to direct Azad Maidan Police Station to register FIR as per section 156(3) of Criminal Procedure Code for offences committed as per section 383, 468, 469, 500, 503, 120 (B), read with 34 of Indian Penal Code against Pranidhi Commerce Private Limited, its Directors viz. Pramod Jain, Sahib Singh Gusain, Lalit Gupta and Plus Corporate Ventures Private Limited, its Director viz. Sahib Singh Gusain, and Ashok Purohit, and Marubhumi Consultants Private Limited, its Directors viz. Sushil Kumar Purohit, Bimal Kumar Joshi, and Enrich Consulting Private Limited, its Directors viz. Hiteshkumar Chhaganlal Kothari, Jayantilal K Thakker, and AHK Developers Private Limited, its Directors viz. Hiteshkumar Chhaganlal Kothari, Arti Hiteshkumar Kothari, and Sachin Kadam and B. B. Chitkara.

The M M court have not issued process or passed any order in this case.

2. Complaint against Rajiv Kashyap, Concord CHS Ltd. And Others

Mr. Ankush Ashok Gupta, has filed a Complaint under Section 420, 500, 405, 425, 427, 120 (B), read with 34 of Indian Penal Code against Rajiv Kashyap, Concord CHS Ltd. One of the promoters, Mrs. Sushma Gupta's, name appears on the website of www.watchoutinvestors.com in relation to loan default by Subhakti Textiles Pvt. Limited in relation to loan taken from Central Bank of India and later referred to DRT. The DRT has sold the assets to SICOM ARC Ltd.(SAL) and SAL has entered into an OTS with Subhakti Textiles Pvt. Ltd, and accordingly a sum of Rs. 225 lacs is payable to SAL. The Company/ Guarantors have paid Rs. 100 lacs till date to SAL.

Mrs. Sushma Gupta is one of the guarantors for the said loan.

b) Complaint under Section 138 of the Negotiable Instruments Act bearing C.C. No. 619/SS of 2006

M/s. Krishna Developers had filed a Complaint under Section 138 of the Negotiable Instruments Act bearing C.C. No. 619/SS of 2006 against accused Q's Fitness Studio and Mr. Ashok Gupta, proprietor of Q's Fitness Studio, in CMM 44th Court, Andheri at Mumbai. The said Complaint was filed due to non-encashment of two Cheques of Rs.23,000,00/- (Rupees Twenty Three Lakhs Each) collectively amounting to Rs.46,000,00/- (Rupees Forty Six Lakhs), which were returned unpaid by the Bankers of the Complainant, due to stop payment instructions issued by Q's Fitness Studio to their Bankers, Bank of Baroda, Saki Naka Branch, Andheri (East), Mumbai. The court vide order dated March 24, 2014 has closed the evidence of accused due to case being of 2006 and there was no reason to keep the matter on same stage for long time and rejected the application of accused vide order dated July 16, 2014..

Mr. Ashok Gupta and Q's Fitness Studio has filed revision bearing Court case no. 904/2014 against above order in the Court of Sessions for Greater Bombay at Mumbai. The matter is pending for hearing.

c) Complaint against Ashok Gupta in the C.C. No. 100943/Cri. Rev. App. of 2012

The state and Mr. Jayesh Himmatlal Pandya, has filed a Complaint under Section 465, 467, 471, 472, 109 and 120 (B), of Indian Penal Code bearing C.C. No. 100943/Criminal Revision Application of 2012 against Mr. Ashok Gupta in 51 Additional Sessions Judge Court, Mumbai. The said Complaint was filed in respect of dispute in respect of flat sold to Gupta family by joint venture company of Shiv Gupta and Hitesh Pandya.

d) Complaint against Ashok Gupta and others in the Long Cause suit No. 3067 of 1996

Minal Co-operative Housing Society Limited has filed Long Cause suit no. 3067 of 1996 in the Bombay City Civil Court against Ratnibai G. Poddar, Kailash G. Poddar, Ashok Gupta and other family members of Joint family for claiming land on which Gurukripa Building, 6 Dixit Road, Vile Parle E, Mumbai - 400057 is situated as their property.

Mr. Ashok Gupta has filed criminal case against original landlord Ratnibai G. Poddar (since deceased) and Mr. Kailash G. Poddar and others for wrongly conveying the above referred land in favour of Minal Co-operative Housing Society Limited.

The next date of hearing is September 11, 2014.

e) Complaint against Ketan Mehta and Ashok Gupta by Mr. Nithish Bangera

Mr. Nithish Bangera had filed complaint u/s. 500 read with 34 of Indian Penal Code bearing CC No. 1343/SS/2012 against Mr. Ketan Mehta, Employee of BSE and Mr. Ashok Gupta, Director of SVC Resources Ltd. with Ld. Metropolitan Magistrate's 68th Court, Borivali, Mumbai for publishing/posting article on BSE website alleging complainant of stealing statutory records and books of records of SVC Resources Ltd.

Mr. Ketan Mehta, had filed Criminal Revision Appeal no. 140 of 2013, against the order passed on the above referred complaint, in the Court of Session at Dindoshi (Borivali Division) at Goregaon Mumbai. The court vide order dated July 14, 2014 allowed the application and quashed the order allowing process against Mr. Ketan Mehta.

Mr. Ashok Gupta, has filed Criminal Revision Appeal no. 78 of 2014, challenging the order of issuance of process passed on the above referred complaint by 68th Metropolitan Magistrate's court at Borivali, in the Court of Session at Dindoshi (Borivali Division) at Goregaon Mumbai.

The next date of hearing is 2nd September 2014.

f) Complaint against Balaji International School in the S.C. Suit No. 2375 of 2009

Mr. Sunilkumar R. Kaniyamparambil, has filed a suit no. S.C. No. 2375 of 2009 against Balaji International School in the Bombay City Civil Court at Bombay (Borivali Division), Dindoshi Goregaon, Mumbai. The Complainant is claiming to be occupying the premises which is just adjacent to the premises of Balaji International School at CTS. No. 383B, Village Valnai, Taluka Borivali, Dist. Ani Anu Developers Pvt. Ltd. has received a notice u/s. 156 of the Income Tax Act, 1961 for AY 2007-08 dated March 15, 2013 issued by Assessing officer, ITO 4 (1) (3), Mumbai demanding a sum of Rs. 27,13,574/ as a penalty u/s. 271 (1) (c) of the Income Tax Act, 1961.

The Company has preferred an appeal before ITAT and the matter is pending.

h) Notice of Demand u/s. 156 of the Income Tax Act, 1961 relating to the Assessment Year 2011-12

SVC Resources Ltd. has received a notice u/s. 156 of the Income Tax Act, 1961 for AY 2011-12 dated March 24, 2014 issued by DCIT, Range 8(3), Mumbai demanding a sum of Rs. 16,84,500/ as a tax on the revision of income done by the Income Tax Department.

The Company has preferred an appeal before CIT (Appeals) and the matter is pending.

i) Letter from Office of the ROC, Maharashtra, Mumbai

SVC Resources Ltd. has received a letter dated April 01, 2013 forwarding the complaint received from Mr. Pramod Jain alleging that open offer was not given for change of management, the directors have defaulted u/s. 274 (1)(g), correct annual report not submitted to BSE and to ROC amongst others. The ROC has directed the Company to submit the point wise reply and documentary evidence wherever is necessary. There is no further communication.

j) Letter from Office of the ROC, Maharashtra, Mumbai

Santowin Corporation Ltd. has received a letter dated May 24, 2013 from the office of the ROC, Maharashtra, Mumbai forwarding the complaint received from Mr. Pramod Jain for alleged violations under the Companies Act, 1956, Listing Agreements etc. The ROC has directed the Company to submit the point wise reply and documentary evidence wherever is necessary. The ROC further sent the letter dated July 18, 2013 and August 2, 2013 demanding a reply on the above referred complaint.

Further, ROC vide order u/s. 234(3A) dated May 20, 2014 communicated to the Company to show cause why an action u/s. 234 (4) of the Companies Act, 1956 should not be initiated against the Company and its directors for non-furnishing of adequate reply to above referred letters.

The company has replied to RoC vide letter dated June 05, 2014 and requested for the personal hearing in the matter before proceeding with any action u/s 234(3A) & (4a).

k) Letter from Office of the ROC, Maharashtra, Mumbai

Santowin Corporation Ltd. has received a letter dated July 26, 2013 from the office of the ROC, Maharashtra, Mumbai forwarding the complaint received from Mr. Anil Kumar Poddar alleging violations under the Companies Act, 1956, Listing Agreements etc. The ROC has directed the Company to submit the point wise reply and documentary evidence wherever is necessary.

The Company has filed reply with CLB, Western Region Bench, Mumbai on October 18, 2013. There is no further communication/ actions from ROC.

l) Suit in the Court of Small Causes at Bombay in the matter of M/s. Raj Dadarkar & Associates vs. Power House Fitness Limited

M/s. Raj Dadarkar & Associates have filed suit against Power House Fitness Limited for eviction, injunction and recovery of arrears of compensation (Rent) of Rs. 1,18,98,000/-, in terms of Leave and Licence Agreement and Business service Agreement, both dated November 20, 2008 for property situated at Shop no. 35, Sai Baba Shopping Center, Near Navjivan Society, Mumbai Central, Mumbai – 400008, in the Court of Small Causes at Bombay. The Power House Fitness Limited as contended the matter based on non-compliance of terms and conditions of Leave and Licence Agreement and Business service Agreement.

The Court has passed an interim order dated November 19, 2013, partially allowing the application, directing Power House Fitness Limited to deposit the arrears of compensation @ Rs. 150000 p.m. from September 2011 to November 2013 and further deposit Rs. 150000 p.m. till the decision of suit.

Power House Fitness Limited had preferred a Revision appeal no. 320 of 2013 with Appellate Bench in the same court against interim order dated November 19, 2013 and the appellate court has dismissed the revision application vide order dated February 01, 2014.

Aggrieved by these orders, Power House Fitness Limited has filed writ petition no. 6975 (st) of 2014 in the High Court of Judicature at Bombay, Civil Jurisdiction to quash and set aside the order dated February 01, 2014 and stay the implementation of interim order date November 19, 2013.

The next date of hearing is 11th October, 2014.

m) Two Director Identification Numbers (DIN) allotted to Mr. Ashok Gupta

Mr. Ashok Gupta, one of the Promoter group entity, was allotted two DINs viz. 00148126 and 00625213 in response to his application for DIN u/s. 266B of the Companies Act, 1956. MR. Ashok Gupta has applied to the Regional Director (Northern Region), Noida for cancellation of the DIN number 00625213 on November 30, 2013.

n) SEBI Letter dated June 28, 2013

SEBI had received complaint against Mr. Ashok Gupta alleging that Mr. Ashok Gupta and his connected entities have acquired the control of SVC Resources Limited during June 2006 to September

2006 without complying with the open offer requirements of SEBI (SAST) Regulations, 1997. It was further alleged that Mr. Gupta's family members acquired shares of Santowin Corporation Limited and took over management control without complying with the open offer requirements of SEBI (SAST) Regulations, 1997. It was also alleged that pledge of shares of SVC Resources Limited and Santowin Corporation Limited was done without complying with disclosure requirements.

SEBI vide letter dated June 28, 2013 sought details of acquisition of shares of SVC Resources Limited by Mr. Ashok Gupta and his family members/ other related entities during June 2006 to September 2006 and Santowin Corporation Limited during March 2010 to June 2010 and the names of Companies where positions held as directors and comments of Mr. Gupta on the above referred allegations.

There is no further correspondence on the matter.

o) SEBI Letter dated September 26, 2012 and June 04, 2013

SEBI had received complaint from Dr. Savinder Singh against SVC Resources Limited alleging that its Directors Mr. Sunil B. Jain, Mr. Vishal Singh, Mr. Rajesh Kapoor and Mr. Mukesh Arora have acquired control of the Company in November 2011, without making any open offer.

SEBI vide letter dated September 26, 2012 sought comments from the Company on the issues raised in the above referred complaint. The Company had replied vide letter dated October 12, 2012 seeking more time to send detailed reply. SEBI vide letter dated June 04, 2013 again wrote to the Company to provide the comments on the issues raised in the above referred complaint and address the complaint forwarded through SCORES on August 30, 2012.

There is no further correspondence on the matter.

p) Income Tax Matter regarding Ashok Gupta HUF for for AY 2009-10 and AY 2010-11

There was a survey conducted by Income Tax Department on Ashok Gupta HUF (The Assessee) on January 31, 2012 and they had done certain addition to Ashok Gupta HUF Income as a part of assessment proceedings for AY 2009-10 and AY 2010-11. The total addition aggregated to approximately Rs. 7 crores. During the survey, they have taken custody of property documents relating to our gym situated at Concord, Juhu among other things and have kept with them as a security for recovery of the tax arising from addition to income. There is no physical attachment of the above referred property and our Company is still using the same. Ashok Gupta HUF, assessee and owner of the property has filed an appeal to contest the addition of Income with the Income Tax Appellate Tribunal for AY 2009-10 and with Commissioner of Income Tax Appellate AY 2010-11. Both the appeals are pending.

Pramod Jain, Sahib Singh Gusain, Lalit Gupta and Plus Corporate Ventures Private Limited, its Director viz. Sahib Singh Gusain, and Ashok Purohit, and Marubhumi Consultants Private Limited, its Directors viz. Sushil Kumar Purohit, Bimal Kumar Joshi, and Enrich Consulting Private Limited, its Directors viz. HiteshkumarChhaganlal Kothari, Jayantilal K Thakker, and AHK Developers Private Limited, its Directors viz. HiteshkumarChhaganlal Kothari, Arti Hiteshkumar Kothari, and Sachin Kadam and B. B. Chitkara.

The process is yet to be issued by M. M. Court.

2. Complaint u/s. 138 of Negotiable Instruments Act, 1881 bearing C.C. No. 1515/SS of 2014

Sri Balaji International School trust has issued notice u/s. 138 of the Negotiable Instrument Act, 1881 to Mr. Pramod Dubey for recovery of Rs. 1.50 crore being sale consideration paid towards purchase of plot of land. The cheque no. 104361 dated 30.12.2013 amounting to Rs. 1.50 crore drawn on Axis Bank, Borivali East branch, Mumbai, issued by Mr. Pramod Dubey was returned unpaid with remark “Funds Insufficient”.

Sri Balaji International School trust through its trustee Mr. Akshat Ashok Gupta has filed case bearing C.C. No. 1515/SS of 2014 for recovery of the above referred money.

The next date of hearing is 14th November, 2014.

3. Complaint for registering FIR u/s. 156(3) CPC against Anju Jalaj Batra and others

Mr. Ashok Gupta as a Managing Director of SVC Resources Limited has filed a complaint before the Metropolitan Magistrate Court at Andheri, Mumbai dated April 24, 2013 to direct MIDC Police Station to register FIR as per section 156(3) of Criminal Procedure Code for offences committed as per section 379, 420, 405, 408, 477A, 504, 506, 507, 114, 201 & 120 (B), read with 34 of Indian Penal Code along with section 630 of Indian Companies Act 1956 against Ms. Anju Jalaj Batra, Shri Kalpesh Chaiwala, Ms. Geeta Vishal Singh, Ms. Sangeeta Kalpesh Chaiwala, Sunil B. Jain, Pramod Agnivanshi, Mr. Nitish Bangera, Vishal Kumar Singh, Mr. Mukesh Arora, Mr. Rajesh Balbir Kapoor, Ashish Lodge, Ashish Jain, Vijay Poddar, Pranidhi Commerce Private Limited, its Directors viz. Pramod Jain, Sahib Singh Gusain, Lalit Gupta and Plus Corporate Ventures Private Limited, and Ashok Purohit, and Marubhumi Consultants Private Limited, its Directors viz. Sushil Kumar Purohit, Bimal Kumar Joshi, and Enrich Consulting Private Limited, its Directors viz. Hitesh Kumar Chhaganlal Kothari, Jayantilal K Thakker, and AHK Developers Private Limited, its Director viz. Arti Hitesh Kumar Kothari, and Sachin Kadam and B. B. 4. Complaint for registering FIR u/s. 156(3) of CPC against Mohit Khullar and others

Mr. Ashok Gupta has filed a complaint before the Metropolitan Magistrate Court at Andheri, Mumbai dated February 15, 2014 to direct Vile-Parle Police Station and/or EOW, GBCB Crime Branch to lodge FIR as per section 156(3) of Criminal Procedure Code for offences committed as per section 464, 468, 471, 469, 167, 474, 120 (B), 506 Part II, 500 of Indian Penal Code against Mohit Khullar, Nithish Bangera, Sameer Relia, Rajesh Baheti & others, Sunil Jain, Jalaj Batra, Vishal Singh, Anju Jalaj Batra, Pramod Jain, Sangeeta Chaiwala, Kalpesh Chaiwala, Vijay Poddar for hatching Criminal Conspiracy, fraud, cheating, breach of trust, criminal trace pass and cybercrime u/s. 67 of I T Act 2000 and against Sanjeet Kumar Chourasia, Manoharlal Agarwal, Arun Kumar Ganeriwal, from Kolkatta for filing false FIR against SVC Resources Limited and to investigate the matter and punish all the above persons as per law. The next date of hearing is October, 22, 2014.

5. Complaint u/s. 138 of Negotiable Instruments Act, 1881

Mr. Ashok Gupta has filed a Complaint under Section 138 of the Negotiable Instruments Act bearing C.C. No. 1437/SS of 2006 against Mr. Rajiv Kashyap, proprietor of Krishna Developers, in CMM 23rd Esplanade Court, Mumbai. The said Complaint was filed due to dishonour of five Cheques (*Rupees Two Lacs each*) collectively amounting to Rs.10,00,000/- (*Rupees Ten Lacs only*) which were returned unpaid by the Bankers to the Complainant, due to stop payment instructions issued by Krishna Developers to their Bankers, Allahabad Bank, Juhu, Vile Parle Branch. The last hearing of the matter was on January 9, 2008. At present the matter is at pending for further hearing.

6. Arbitration Petition No.68/2007 in the matter of Rajiv Kashyap

Mr. Ashok Gupta and others, vide agreement dated October 21, 2005 purchased a flat, measuring about 1400 sq.ft with 600 sq.ft of terrace area from Krishna Developers for an amount of Rs.77,00,000 (*Rupees Seventy Seven lacs only*). Subsequently, because of certain disputes relating to the repair work of the said flat, Mr. Ashok Gupta invoked the arbitration clause embodied in the agreement dated against Mr. Rajiv Kashyap and the said matter was referred to Arbitration. Hon'ble Mr. Justice H. Suresh (Retired) presiding in the aforesaid matter, passed an award dated December 7, 2006 dismissing Mr. Gupta's claim. Being aggrieved by the said award, Mr. Gupta the Petitioner, filed an Arbitration Petition No.68/2007 before the Hon'ble High Court of Mumbai, for setting aside the award passed by the learned Arbitrator. The matter is pending for final arguments.

7. Complaint against Mr. Rajiv Kashyap and Other in the C.C. No. 1000556/SW of 2013

Mr. Ashok Gupta, has filed a Complaint under Section 201, 417, 420, 406, 425, 427, 467, 477A, 500, 120 (B), read with 34 of Indian Penal Code bearing C.C. No. 1000556/SW of 2013 against Mr. Rajiv Kashyap, Concord CHS and Mohid Builders, in 10th Court of Metropolitan Magistrate, Mumbai. The said Complaint was filed for various illegal work carried out in the Concord CHS building. At present the enquiry/ investigation is in progress with Juhu Police station.

8. Complaint against Concord CHS Ltd. And Others in the C.C. No. 1000124/SW of 2013

Mr. Ashok Gupta, has filed a Complaint under Section 420, 500, 425, 427, 120 (B), read with 34 of Indian Penal Code bearing C.C. No. 1000124/SW of 2013 against Concord CHS Ltd. Ramesh Jani, Mira Chakravorthy, ABIDI, Manjula Mani, MohidZahoor, in 10th Court of Metropolitan Magistrate, Mumbai. The said Complaint was filed for issuance of process against all so that injustice made on Ashok Gupta is removed for the purchase of flat, unit, show rooms in Concord CHS Ltd. after obtaining NOC from society. The next date of hearing is September 23, 2014.

9. Criminbal Complaint against Ratnibai G. Poddar (since deceased) & Kailash G. Poddar and others in C. C. No. 34/2008/SS

Mr. Ashok Gupta has filed criminal case No. 34/2008/SS (original case no. 45/S of 1998) in the Spl. Metropolitan Magistrate Court at Andheri, Mumbai against original landlord Ratnibai G. Poddar (since deceased) and Mr. Kailash G. Poddar and Others for wrongly conveying the land on which Gurukripa Building, 6 Dixit Road, Vile Parle E, Mumbai - 400057 is situated in favour of Minal Co-operative Housing Society Limited. The next date of hearing is November 01, 2014.

- 2. The name of one of our Promoter, Mrs. Sushma Gupta is appearing on the website 'http://www.watchoutinvestors.com/' in the DRT matter of Subhakti Textiles Limited and Leader Packaging Industries Limited. Mrs. Sushma Gupta was never a director in Leader Packing Industries Limited. She was only a shareholder of the same. Entire shareholding of Ashok Gupta family was transferred by the Ashok Gupta Family prior to 1995 only, since then none of the family members of Ashok Gupta family is associated in any manner with Leader Packing Industries Limited. Subhakti Textiles belongs to Mr. Mahesh Gupta, brother of Mr. Ashok Gupta. Mrs. Sushma Gupta was only director of Subhakti Textiles and had resigned in the year 2003. There has been family separation within the Gupta Family in the year 2009 and accordingly Mr. Ashok Gupta, Mr. Mahesh Gupta and Mr. Shiv Gupta have sparated in the year 2009. Since then Mr. Ashok Gupta family has no connection with the Companies of his brother. However the name of Mrs. Sushma Gupta still appears on watchoutinvestors.com in the matter of above companies. As on date Mrs. Sushma Gupta has no connection Mrs. Sushma Gupta has initiated the process for the removal of her name from 'http://www.watchoutinvestors.com/'.**
- 3. The premises at which our registered office is situated and our Gyms are situated may be subject matter of dispute.**

Our registered office and gyms are located at premises which are not owned by our Company. We are occupying these premises on leave and licence basis. Our Gym situated at Mumbai Central is under dispute with M/s. Raj Dadarkar & Associates and our registered office is in dispute with M/s Krishna Developers. For further details regarding the same, please refer to the chapter titled 'Outstanding Litigations and Material Developments' beginning on page 126 of the Prospectus. We cannot assure you that we will own, or have the right to occupy, these premises in the future, or that we will be able to continue with the uninterrupted use of this property, which may impair our operations and adversely affect our financial condition. We further cannot assure you that there will be no dispute with respect to other gyms occupied by us currently or to be occupied by us in future. The disputes, if any, may impair our operations and adversely affect our financial condition. For further details of our office premises please refer to the section titled "Our Business Overview" on page 71 of this Prospectus.

- 4. There was a fire at our Mumbai Central Gym, on September 2, 2014. There was loss of machiney and fixtures and furniture of approximately Rs. 30 Lacs. We are in the process of filing the claim with the insurance company. Further the gym is also not operating since the happening of fire resulting in revenue losses to our Company. We also cannot assure you that there will be no such incidents in future**

and any future incident of this kind may impair our operations and adversely affect our financial condition.

5. *Our Company had negative cash flow in recent fiscal, details of which are given below. Sustained negative cash flow could adversely impact our business, financial condition and results of operations.*

Cash flow of a company is a key indicator to show the extent of cash generated from operations to meet its capital expenditure, pay dividends, repay loans and make new investments without raising finance from external resources. If we are not able to generate sufficient cash flow, it may adversely affect our business and financial operations. For further details please refer to the section titled 'Financial Information' and chapter titled 'Management's Discussion and Analysis of Financial Condition and Results of Operations' beginning on page 106 and 122, respectively, of the Prospectus.

6. *The objects of the Issue for which funds are being raised have not been appraised by any bank or financial institution. The deployment of funds in the project is entirely at the discretion of our management and as per the details mentioned in the section titled "Objects of the Issue". Any revision in the estimates may require us to reschedule our project expenditure and may have a bearing on our expected revenues and earnings.*

Our funding requirements and the deployment of the proceeds of the Issue are purely based on our management's estimates and have not been appraised by any bank or financial institution. Our Company may have to revise such estimates from time to time and consequently our funding requirements may also change. Our estimates for expansion may exceed the value that would have been determined by third party appraisals and may require us to reschedule our expenditure which may have a bearing on our expected revenues and earnings. Further, the deployment of the funds towards the objects of the Issue is entirely at the discretion of our management and is not subject to monitoring by any external independent agency. However, the deployment of funds is subject to monitoring by our Audit Committee.

7. *Our Company has not yet placed orders for equipments aggregating ₹300.00 lacs required by us for the proposed expansion. Any delay in placing the orders / or supply of plant and machinery may result in time and cost overruns, and may affect our profitability.*

Our Company propose to acquire plant and machinery aggregating ₹ 300.00 lacs for our proposed project which is 41.67% of the Issue Proceeds. Our Company has not yet placed orders for plant and machinery aggregating ₹ 300 lacs required by us which constitutes 100 % of the total plant and machinery propose to be acquired for our proposed expansion. Our Company is further subject to risks on account of inflation in the price of plant and machinery. Since the funding for the plant and machinery is solely from the IPO proceeds, any delay in access to IPO proceeds would eventually delay the process of placing the orders. The purchase of equipments would require us to consider factors including but not limited to pricing, delivery schedule and after-sales maintenance. There may also be a possibility of delay at the suppliers' end in providing timely delivery of these equipments, which in turn may delay the implementation of our project.

8. *We have not made any alternate arrangements for meeting our capital requirements for the Objects of the issue. Further we have not identified any alternate source of financing the 'Objects of the Issue'. Any shortfall in raising / meeting the same could adversely affect our growth plans, operations and financial performance.*

As on date, we have not made any alternate arrangements for meeting our capital requirements for the objects of the issue. We meet our capital requirements through our bank finance, owned funds and internal accruals. Any shortfall in our net owned funds, internal accruals and our inability to raise debt in future would result in us being unable to meet our capital requirements, which in turn will negatively affect our financial condition and results of operations. Further we have not identified any alternate source of funding and hence any failure or delay on our part to raise money from this issue or any shortfall in the issue proceeds may delay the implementation schedule and could adversely affect our growth plans. For further details please refer to the chapter titled "Objects of the Issue" beginning on page 53 of the Prospectus.

- 9. *There can be delay in the schedule of setting up of new Gyms for which the funds are being raised in this Issue. This may affect our financial condition and results of operation.***

We have expansion plans of adding 6 Gyms in Mumbai during the fiscal 2015 for which funds are being raised from this Issue. As on the date of this Prospectus, we have not initiated any activities towards this Object of the Issue and there can be a possibility of us in delaying the schedule of rollout of the health clubs. We will have to identify suitable locations to open and operate the proposed gyms. If we are not able to identify a suitable location within the time and place that we desire or at all, we cannot guarantee that all the 6 health clubs will be rolled out in the fiscal 2015. This may affect our financial condition and results of operation.

- 10. *Q's Fitness Studio, proprietorship concern of Ashok Gupta HUF entered into Master License Agreement with Powerhouse Gyms International in 2005 for a period of 10 years to open gyms under the Powerhouse Gym name in India, Sri Lanka, Nepal, Bangladesh and Maldives. Subsequently in October 2009, Q's Fitness Studio entered into an addendum agreement wherein it was agreed to grant 5 year extension upon payments being brought current. We have been authorised by Q's Fitness Studio to use the brand 'Powerhouse Gym' for our business in India. We along with Q's Fitness Studio negotiating with Powerhouse Gyms International for revised terms and extension of contract. In the event wherein we are unable to renew the contract we might have to change the brand name and which may adversely effect our business operations.***

- 11. *Third Party liability / Members getting injured or dying at our premises could result in a loss or shutdown of operations***

Our gyms are used by many members on a daily basis. Sometimes members may fall down while working out may result in loss of life / damage to life. While, till date, there have not been any incidents involving mishaps or major accidents, we cannot assure that these may not occur in the future. Any consequential losses arising due to such events will affect our operations and financial condition.

- 12. *The loss of key suppliers or their failure to deliver equipment and material on a timely basis could negatively impact our business prospects and results of operations.***

We rely on various suppliers to provide spare parts and equipment. We must have an adequate supply of such materials to continue our business. We purchase all the required materials from our suppliers on a purchase order basis and have no long-term contracts with any suppliers. If the suppliers, are unable to supply us with these materials services in a timely manner or the costs of these services increase due to unforeseen circumstances, this could negatively impact our operating results

- 13. *Our operations are significantly located in the Mumbai and failure to expand our operations may restrict our growth and adversely affect our business***

Currently, registered office is situated in Mumbai and we are carrying our business mainly in Mumbai. Hence our major revenues are generated from operations in this region only. In the event that demand for our services in general reduces or stops by any reason including political discord or instability or change in policies of State, then our financial condition and operating results may be materially and adversely affected. Geographical and functional expansion of our business domain requires establishment of adequate network. As we seek to diversify our regional focus we may face the risk that our competitors may be better known in other markets, enjoy better relationships with customers. Our lack of exposure in geographical boundaries outside our operating region could impact our future revenues.

- 14. *Our business requires us to obtain and renew certain registrations, licenses and permits from government and regulatory authorities and the failure to obtain and renew them in a timely manner may adversely affect our business operations.***

Our business operations require us to obtain and renew from time to time, certain approvals, licenses, registrations and permits, some of which may expire and for which we may have to make an application for obtaining the approval or its renewal. We will be applying for certain approvals relating to our business. If we fail to maintain such registrations and licenses or comply with applicable conditions, or a regulatory authority claims we have not complied, with these conditions, our certificate of registration for carrying on a particular activity may be suspended and/or cancelled and we will not then be able to carry on such activity.

Further, we may become liable to penal action if our activities are adjudged to be undertaken in the manner not authorized under the applicable law. This could materially and adversely affect our business, financial condition and results of operations. We cannot assure you that we will be able to obtain approvals in respect of such applications or any application made by us in the future. For more information about the licenses required in our business and the licenses and approvals applied for, please refer to sections titled “Government and other Key Approvals” beginning on page 135 of the Prospectus.

15. *Our success depends largely upon the services of our Directors and other Key Managerial Personnel and our ability to attract and retain them. Demand for Key Managerial Personnel in the industry is intense and our inability to attract and retain Key Managerial Personnel may affect the operations of our Company.*

Our Executive Director, Mr. Akshat Gupta and our Whole-time Director, Mr. Ankush Gupta has built relations with clients and other persons who are connected with us. Our success is substantially dependent on the expertise and services of our Directors and our Key Managerial Personnel. They provide expertise which enables us to make well informed decisions in relation to our business and our future prospects. Our future performance will depend upon the continued services of these persons. Demand for Key Managerial Personnel in the industry is intense. We cannot assure you that we will be able to retain any or all, or that our succession planning will help to replace, the key members of our management. The loss of the services of such key members of our management team and the failure of any succession plans to replace such key members could have an adverse effect on our business and the results of our operations.

16. *We face intense competition in our businesses, which may limit our growth and prospects.*

Our Company faces significant competition from other players in the gym and fitness industry. In particular, we compete with other brands in the markets in which we are present. We compete on the basis of a number of factors, including execution, depth of product and service offerings, innovation, reputation and price. Our competitors may have advantages over us, including, but not limited to:

- Substantially greater financial resources;
- Longer operating history than in certain of our businesses;
- Greater brand recognition among consumers;
- Larger customer bases in and outside India; or
- More diversified operations which allow profits from certain operations to support others with lower profitability.

These competitive pressures may affect our business, and our growth will largely depend on our ability to respond in an effective and timely manner to these competitive pressures.

17. *Our ability to pay dividends in the future will depend upon future earnings, financial condition, cash flows, working capital requirements and capital expenditures.*

We have not paid any dividends since incorporation. Our future ability to pay dividends will depend on our earnings, financial condition and capital requirements. Dividends distributed by us will attract dividend distribution tax at rates applicable from time to time. There can be no assurance that we will generate sufficient income to cover the operating expenses and pay dividends to the shareholders.

Our ability to pay dividends will also depend on our expansion plans. We may be unable to pay dividends in the near or medium term, and the future dividend policy will depend on the capital requirements and financing arrangements for the business plans, financial condition and results of operations.

18. *We do not own our Registered Office from which we operate.*

We do not own the premises on which our Registered Office is situated. Mr. Akshat Gupta & Mr. Ankush Gupta, *vide* their letter dated April 1, 2014, has given the office premises to be used as the registered office, without payment of any lease rent and/or deposit. We cannot assure you that we will own, or have the right

to occupy, these premises in the future, or that we will be able to continue with the uninterrupted use of this property, which may impair our operations and adversely affect our financial condition. For further details of our office premises please refer to the section titled "Our Business Overview" on page 71 of this Prospectus.

20. Future issuances of Equity Shares or future sales of Equity Shares by our Promoters and certain shareholders, or the perception that such sales may occur, may result in a decrease of the market price of our Equity Shares.

In the future, we may issue additional equity securities for financing our capital requirements. In addition, our Promoters and certain shareholders may dispose off their interests in our Equity Shares directly, indirectly or may pledge or encumber their Equity Shares. Any such issuances or sales or the prospect of any such issuances or sales could result in a dilution of shareholders' holding or a negative market perception and potentially in a lower market price of our Equity Shares.

21. The equity shares of Santowin Corporation Limited, our Promoter Group Entity were suspended for trading by BSE for non-compliances with listing agreement in November 2007. However the suspension was revoked later and was resumed for trading w.e.f. October 20, 2010.

22. The growth of our business may require us to obtain substantial financing, which we may not be able to obtain on reasonable terms or at all. We may need to raise additional funds through incurring debt to satisfy our capital needs, which we may not be able to procure on acceptable terms or at all.

Our growth is dependent on having a strong balance sheet to support our activities. In addition to the Net Proceeds and our internally generated cash flow, we may need other sources of financing to meet our capital needs which may include entering into new debt facilities with lending institutions or raising additional debt or equity in the capital markets. We may need to raise additional capital from time to time, depending on business conditions. The factors that would require us to raise additional capital could be business growth beyond what our current balance sheet can sustain; additional capital requirements imposed due to changes in the regulatory regime or new guidelines; or significant depletion in our existing capital base due to unusual operating losses. Any fresh issue of shares or convertible securities would dilute existing shareholding, and such issuance may not be done at terms and conditions that are favourable to the existing shareholders of the Company.

If we decide to raise additional funds through the incurrence of debt, our interest obligations will increase and we may be subject to additional covenants, which could further limit our ability to access cash flows from our operations. Such financing could cause our debt to equity ratio to increase or require us to create further charges or liens on our assets in favour of lenders. We cannot assure you that we will be able to secure adequate financing in the future on acceptable terms, in time, or at all. Our failure to obtain sufficient financing could result in the delay or abandonment of our expansion plans. Our business and future results of operations may be adversely affected if we delay or are unable to implement our expansion strategy.

23. Covenants with institutional lenders may restrict our operations and expansion ability, which may affect our business and results of operations and financial condition.

As per our current financing arrangements with banks, we are subject to certain restrictive covenants which require us to obtain the prior consent of the respective lenders before undertaking certain actions such as:

- effect any change in the capital structure
- formulate any scheme of amalgamation or reconstruction.
- implement any scheme of expansion or acquire fixed assets.
- make investments/ advances or deposit amounts with any other concern.
- enter into borrowing arrangements with any bank/FI/company.
- undertake guarantee obligations on behalf of any other company.
- declare dividends for any year except out of profits relating to that year

Although have applied for the NoC cum Consent from our lenders for this issue, we can not assure you that we will be able to receive such consents.

24. *We have unsecured loans, which are repayable on demand. Any demand from lenders for repayment of such unsecured loans, may adversely affect our business operations.*

As per our restated financial statements, as on March 31, 2014, we have unsecured loan of ₹ 10.00 lacs which is repayable on demand. Any demand from lenders for repayment of such unsecured loans, may adversely affect our business operations and liquidity. For further details of these unsecured loans, please refer to Auditors' Report beginning on page 157 of the Prospectus.

25. *We have in the past entered into related party transactions and may continue to do so in the future.*

We have entered into transactions with our Promoters and our Promoter Group. While we believe that all such transactions have been conducted on an arm's length basis, there can be no assurance that we could not have achieved more favorable terms had such transactions not been entered into with related parties. Furthermore, it is likely that we may enter into related party transactions in the future. There can be no assurance that such transactions, individually or in the aggregate, will not have an adverse effect on our financial condition and results of operations. For further details, please refer to "Annexure XV – Related Party Transactions" of the "Auditors Report" beginning on page 119 of this Prospectus.

26. *Our insurance cover may be inadequate to fully protect us from all losses and may inturn adversely affect our financial condition.*

We maintain such insurance coverage as we believe is customary for our Company. Our insurance policies, however, may not provide adequate coverage in certain circumstances and are subject to certain deductibles, exclusions and limits on coverage. We maintain premises and vehicle insurance coverage. However, we cannot assure you that the terms of our insurance policies will be adequate to cover any damage or loss suffered by us or that such coverage will continue to be available on reasonable terms or will be available in sufficient amounts to cover one or more large claims, or that the insurer will not disclaim coverage as to any future claim. Further, there can be no assurance that any claim under the insurance policies maintained by us will be honoured fully, in part or on time. To the extent that we suffer loss or damage that is not covered by insurance or which exceeds our insurance coverage, our results of operations or cash flow may be affected.

27. *The requirements of being a listed company may strain our resources.*

As a listed company, we will incur significant legal, accounting, corporate governance and other expenses that we did not incur as an unlisted company. We will be subject to the listing agreements with the BSE, which require us to file audited annual and unaudited quarterly reports with respect to our business and financial condition. If we experience any delays, we may fail to satisfy our reporting obligations and/or we may not be able to readily determine and accordingly report any changes in our results of operations as timely as other listed companies. As a listed company, we will need to maintain and improve the effectiveness of our disclosure controls and procedures and internal control over financial reporting, for which significant resources and management overview will be required.

EXTERNAL RISKS

1. *We cannot predict the effect of the proposed notification of the Companies Act, 2013 on our business.*

The Companies Act, 2013 (the “2013 Act”) has been notified by the Government of India on August 30, 2013 (the “Notification”). Under the Notification, Section 1 of the 2013 Act has come into effect and the remaining provisions of the 2013 Act have and shall come into force on such dates as the Central Government has notified and shall notify. Section 1 of the 2013 Act deals with the commencement and application of the 2013 Act, and among others, sets out the types of companies to which the 2013 Act applies. Further the Ministry of Corporate Affairs has by their notification dated September 12, 2013 notified 98 sections of the 2013 Act, which have come into force from September 12, 2013.

The 2013 Act is expected to replace the existing Companies Act, 1956. The 2013 Act provides for, among other things, changes to the regulatory framework governing the issue of capital by companies, corporate governance, audit procedures, corporate social responsibility, the requirements for independent directors, director’s liability, class action suits, and the inclusion of women directors on the boards of companies. The 2013 Act is expected to be complemented by a set of rules that shall set out the procedure for compliance with the substantive provisions of the 2013 Act. In the absence of such rules, it is difficult to predict with any degree of certainty the impact, adverse or otherwise, of the 2013 Act on the Issue, and on the business, prospects and results of operations of the Company. Further, as mentioned above, certain provisions of the 2013 Act have already come into force and the rest shall follow in due course. In event some or all of the provisions of the 2013 Act and the rules thereto are notified prior to the consummation of the Issue, we may have to undertake certain additional actions that we are not currently aware of (in the absence of the rules), which may result in delay of the Issue.

2. *We cannot guarantee the accuracy or completeness of facts and other statistics with respect to India, the Indian economy and the financial services sector contained in the Prospectus.*

While facts and other statistics in the Prospectus relating to India, the Indian economy and the financial services sector has been based on various government publications and reports from government agencies that we believe are reliable, we cannot guarantee the quality or reliability of such materials. While we have taken reasonable care in the reproduction of such information, industry facts and other statistics have not been prepared or independently verified by us or any of our respective affiliates or advisors and, therefore we make no representation as to their accuracy or completeness. These facts and other statistics include the facts and statistics included in the chapter titled ‘*Industry Overview*’ beginning on page number 68 of the Draft Red Herring Prospectus. Due to possibly flawed or ineffective data collection methods or discrepancies between published information and market practice and other problems, the statistics herein may be inaccurate or may not be comparable to statistics produced elsewhere and should not be unduly relied upon. Further, there is no assurance that they are stated or compiled on the same basis or with the same degree of accuracy, as the case may be, elsewhere.

3. *Global economic, political and social conditions may harm our ability to do business, increase our costs and negatively affect our stock price.*

Global economic and political factors that are beyond our control, influence forecasts and directly affect performance. These factors include interest rates, rates of economic growth, fiscal and monetary policies of governments, inflation, deflation, foreign exchange fluctuations, consumer credit availability, consumer debt levels, unemployment trends, terrorist threats and activities, worldwide military and domestic disturbances and conflicts, and other matters that influence consumer confidence, spending and tourism. Increasing volatility in financial markets may cause these factors to change with a greater degree of frequency and magnitude.

4. *Global economic conditions have been unprecedented and continue to have, an adverse effect on the global and Indian financial markets which may continue to have a material adverse effect on our business.*

Recent global market and economic conditions have been unprecedented and challenging with tighter credit conditions and an economic recession has been witnessed in most economies in 2009. Continued concerns about the systemic impact of potential long-term and wide-spread economic recession, energy costs, geopolitical issues, the availability and cost of credit, and the global housing and mortgage markets have contributed to increased market volatility and diminished expectations for western and emerging economies. These conditions, combined with volatile oil prices, declining business and consumer confidence and increased unemployment, have contributed to volatility of unprecedented levels. As a result

of these market conditions, the cost and availability of credit has been and may continue to be adversely affected by illiquid credit markets and wider credit spreads. Concern about the stability of the markets generally and the strength of counterparties specifically has led many lenders and institutional investors to reduce, and in some cases, cease to provide credit to businesses and consumers. These factors have led to a decrease in spending by businesses and consumers alike and corresponding decreases in global infrastructure spending and commodity prices. These market and economic conditions have an adverse effect on the global and Indian financial markets and may continue to have a material adverse effect on our business and financial performance, and may have an impact on the price of the Equity Shares.

5. Any disruption in the supply of power, IT infrastructure, telecom lines and disruption in internet connectivity could disrupt our business process or subject us to additional costs.

Any disruption in basic infrastructure or the failure of the Government to improve the existing infrastructure facilities could negatively impact our business since we may not be able to provide timely or adequate services to our clients. We do not maintain business interruption insurance and may not be covered for any claims or damages if the supply of power, IT infrastructure, internet connectivity or telecom lines is disrupted. This may result in the loss of a client, impose additional costs on us and have an adverse effect on our business, financial condition and results of operations and could lead to decline in the price of our Equity Shares.

6. Natural calamities and changing weather conditions caused as a result of global warming could have a negative impact on the Indian economy and consequently impact our business and profitability.

Natural calamities such as draughts, floods, and earthquakes could have a negative impact on the Indian economy and may cause suspension, delays or damage to our current projects and operations, which may adversely impact our business and our operating results. India's being a monsoon driven economy, climate change caused due to global warming bringing deficient / untimely monsoons could impact Government policy which in turn would adversely affect our business.

7. Political instability or changes in the Government could adversely affect economic conditions in India generally and our business in particular.

The Government of India has traditionally exercised and continues to exercise a significant influence over many aspects of the economy. Our business, and the market price and liquidity of our Equity Shares, may be affected by interest rates, changes in Government policy, taxation, social and civil unrest and other political, economic or other developments in or affecting India. Since 1991, successive governments have pursued policies of economic liberalization and financial sector reforms. However, there can be no assurance that such policies will be continued in the future. A significant change in India's economic liberalization and deregulation policies could disrupt business and economic conditions in India generally and adversely affect our business, financial condition and results of operations.

8. Civil unrest, acts of violence including terrorism or war involving India and other countries could materially and adversely affect the financial markets and our business.

Any major hostilities involving India or other acts of violence, including civil unrest or similar events that are beyond our control, could have a material adverse effect on India's economy and our business. Terrorist attacks and other acts of violence may adversely affect the Indian stock markets, where our Equity Shares will trade, and the global equity markets generally.

9. There is no guarantee that the Equity Shares issued pursuant to the Issue will be listed on the SME Platform of BSE in a timely manner, or at all.

In accordance with Indian law and practice, permission for listing and trading of the Equity Shares issued pursuant to the Issue will not be granted until after the Equity Shares have been issued and allotted. Approval for listing and trading will require all relevant documents authorizing the issuing of Equity Shares to be submitted. There could be a failure or delay in listing the Equity Shares on the SME Platform of BSE. Any failure or delay in obtaining the approval would restrict your ability to dispose of your Equity Shares.

10. The price of our Equity Shares may be volatile, or an active trading market for our Equity Shares may not develop.

Prior to this Issue, there has been no public market for our Equity Shares. Our Company and the Lead Manager have appointed Market Maker for the equity shares of our Company. However, the trading price of our Equity Shares may fluctuate after this Issue due to a variety of factors, including our results of operations and the performance of our business, competitive conditions, general economic, political and social factors, the performance of the Indian and global economy and significant developments in India's fiscal regime, volatility in the Indian and global securities market, performance of our competitors, the Indian Capital Markets and Finance industry, changes in the estimates of our performance or recommendations by financial analysts and announcements by us or others regarding contracts, acquisitions, strategic partnerships, joint ventures, or capital commitments.

In addition, if the stock markets experience a loss of investor confidence, the trading price of our Equity Shares could decline for reasons unrelated to our business, financial condition or operating results. The trading price of our Equity Shares might also decline in reaction to events that affect other companies in our industry even if these events do not directly affect us. Each of these factors, among others, could materially affect the price of our Equity Shares. There can be no assurance that an active trading market for our Equity Shares will develop or be sustained after this Issue, or that the price at which our Equity Shares are initially offered will correspond to the prices at which they will trade in the market subsequent to this Issue. For further details of the obligations and limitations of Market Makers please refer to the chapter titled "General Information" beginning on page 36 of this Prospectus.

11. *There are restrictions on daily movements in the price of the Equity Shares, which may adversely affect a shareholder's ability to sell, or the price at which it can sell, Equity Shares at a particular point in time.*

Following the Issue, we will be subject to a daily "circuit breaker" imposed by BSE, which does not allow transactions beyond specified increases or decreases in the price of the Equity Shares. This circuit breaker operates independently of the index-based, market-wide circuit breakers generally imposed by SEBI on Indian stock exchange. The percentage limit on our circuit breakers will be set by the stock exchange based on the historical volatility in the price and trading volume of the Equity Shares.

The BSE may not inform us of the percentage limit of the circuit breaker in effect from time to time and may change it without our knowledge. This circuit breaker will limit the upward and downward movements in the price of the Equity Shares. As a result of this circuit breaker, no assurance can be given regarding your ability to sell your Equity Shares or the price at which you may be able to sell your Equity Shares at any particular time.

12. *Conditions in the Indian securities market may affect the price or liquidity of our Equity Shares.*

The Indian securities markets are smaller than securities markets in more developed economies and the regulation and monitoring of Indian securities markets and the activities of investors, brokers and other participants differ, in some cases significantly, from those in the more developed economies. Indian stock exchange have in the past experienced substantial fluctuations in the prices of listed securities. Further, the Indian stock exchanges have experienced volatility in the recent times. The Indian stock exchanges have also experienced problems that have affected the market price and liquidity of the securities of Indian companies, such as temporary exchange closures, broker defaults, settlement delays and strikes by brokers. In addition, the governing bodies of the Indian stock exchanges have from time to time restricted securities from trading and limited price movements. A closure of, or trading stoppage on the BSE could adversely affect the trading price of the Equity Shares.

SECTION III – INTRODUCTION

SUMMARY OF OUR INDUSTRY

Indian Fitness & Slimming Industry constitutes about 8% of the wellness market. Presently, the fitness industry is in its nascent stages. The industry is fairly fragmented since the majority of the market appears to be dominated by a large number of mom-and-pop gyms. Organized fitness services account for merely 25% of the overall fitness industry.

Trends in the Industry

The Indian Fitness & Slimming Industry is set to ride high with all levers in place. Growing disposable income of the people coupled with rising awareness of a healthy body augur well for the Industry. Significant changes in lifestyle related to lack of physical activity and increased consumption of fast food among both affluent and working class population has led to greater need for healthy lifestyles. Indian fitness & slimming industry currently pegged at USD 0.78 billion is stated to grow at a CAGR of 25% to reach USD 2.4 Billion by 2015. We would not be surprised if the industry outperforms our ballpark figure.

The fitness industry is highly under penetrated in India with mere 0.4% (taken for top 7 cities) membership as compared to Asia Pacific average of 3.7%. The industry, as a whole, is expected to benefit from rising proportion of age group between 20 and 44 in India, which is expected to be ~40% of India's total population by the end of 2016. In addition, growing disposable incomes and rising lifestyle related diseases would pent up demand for quality health and fitness services.

The Indian wellness industry encompasses a large number of service segments including beauty services (salon, treatment based beauty products), personal health counselling, fitness and rejuvenation segments. The current size of the overall Indian wellness industry is estimated at ~ 49,000 crore. The industry comprises beauty services and cosmetics products, which is estimated at ~20,000 crore. The fitness and slimming market is estimated at ~4,000 crore, nutrition market (includes health and wellness food and beverages) at ~13,000 crore, rejuvenation at ~500 crore and alternate therapy market in India at ~11,500 crore, respectively. Further, according to the Ficci-PwC knowledge report, the Indian wellness industry is expected to grow at a CAGR of 20% for the next three years to reach around 87,500 crore on the back of rising disposable incomes and increasing need to 'look good' among the youth population in India.

We expect the major growth driver for the fitness service industry to be the growing population in urban India. According to census 2011 provisional data, the urban population constituted 31.2% of the total population in 2011. There has been continuous growth in disposable income from 2001-02 to 2009-10. It suggests that the number of households earning below 1.4 lakh per annum declined from 135 million to 114 million in 2009-2010. However, the number of households earning between 3.1 lakh and 15.6 lakh in each segment grew at ~12% CAGR (from 11 million to 28 million) between 2001-02 and 2009-10. With rising income levels, we expect spending to also increase significantly. During the last few years, a sharp rise in wealth can be seen in several posh residential complexes that have emerged in the top few Indian cities like Mumbai, NCR, Chennai, Kolkata, Hyderabad, Bangalore and Pune. This segment of the population provides an upscale market for fitness centres to offer not just the basic gym facility but also advanced value added activities like spas, steam/sauna bath, nutrition centres, aerobics, spinning studios and personal training programmes.

Significant changes in lifestyle related to lack of physical activities and increased consumption of "junk foods" among the young population has created a greater need for a healthy lifestyle through exercise and counselling on dietary habits. According to the International Diabetic Federation, India alone has 61.3 million people living with diabetes. This places India second only to China. Due to its large child population, India accounts for most of the 1,12,000 children with type 1 diabetes. Rising number of diabetic patients in India in the adult age group is creating room for established gyms players to expand gyms with trained employees.

There is a growing demand for wellness services in urban markets beyond Tier 1 cities mainly due to rising awareness in the country on diseases like diabetes. A study of AC Nielsen's Global Online Consumer Survey 2009 reveals that going to gym is the second most preferred option for exercise after walking. Among total respondents, ~35% preferred exercise through walking while only 18% preferred gyms for the exercise. We expect penetration of gyms to increase in the near future with rising income level and awareness about lifestyle diseases among the adult age group.

The gym, health and fitness clubs industry is in the growth stage of its life cycle due to an increased awareness and interest in fitness & health and the need for exercise. Even in the midst of the economic downturn, the industry has maintained steady growth, with membership rates growing consistently and profits remaining solid. Demand for gyms and health and fitness clubs will continue to rise over the next five years as the general public becomes more health conscious and the aging population places a greater emphasis on staying fit. Additionally, the amount of leisure time and growth in household incomes will positively affect businesses, leading operators to expand into larger facilities.

Conclusion

The wellness industry in India is poised to touch Rs 1,00,000 crore (Rs 1 trillion) by 2015, with a compounded annual growth rate of 15-17%, from about Rs 70,000 crore in 2012. Of the entire wellness industry, beauty care would continue to dominate with almost 50% (about Rs 49,000 crore), followed by alternate therapy (about Rs 21,000 crore) and health and wellness food and beverages at about Rs 27,000 crore, according to the study.

The size of the beauty care industry is estimated at Rs 29,000 crore in 2012 estimate, while fitness and slimming market was estimated at Rs 60,000 crore in 2012. About 60% of the market is dominated by products. However, the industry is facing issues in getting standard skilled manpower, and no standard is followed across the industry.

SUMMARY OF OUR BUSINESS

We are a fitness chain operating in Mumbai and also have the presence in Surat and Jaipur through our franchise. We operate our Gyms under the brand “Powerhouse Gyms” which is owned by Powerhouse Gyms International headquartered in Detroit, USA.

Our Gyms are state of the art facilities with services including gyms, steam, aerobics and diet counseling amongst others.

The first gym was established in May 1999, as “Q’s Fitness Studio” a proprietary firm with Mr. Ashok Gupta HUF as its sole proprietor at Santacruz West, Mumbai. After the success of the Santacruz centre another centre was set up at Vile Parle, Mumbai in October 2004.

“Q’s Fitness Studio” has signed a Master Licensing Agreement dated March 21, 2005 with Powerhouse Licensing LLC, which provides us with the exclusive right to set up and operate Powerhouse Gyms and to use and license of the Powerhouse Gyms and the associated trademarks in the gyms in India, Nepal, Bangladesh and Sri Lanka set up and run Powerhouse gyms in India, Sri Lanka, Nepal, Bangladesh and Maldives. The first Powerhouse fitness centre in India was set up in November 2005 at at Juhu (Mumbai). The centres at Santacruz and Vile Parle were converted to Powerhouse.

In February 2013, our Company, Powerhouse Fitness & Realty Limited was incorporated to consolidate the business and bring all the gyms into a single entity. Currently, we have 12 Powerhouse Gyms in Mumbai located at Juhu, Vile Parle, Chembur, Ghatkopar, Mulund(W), Chowpatty, Prabhadevi, Andheri(E), 4 Bungalows, Malad (W), Mumbai Central and Colaba. Our gyms are generally located in neighbourhood markets in Mumbai.

Currently, our Company operates 13 fitness centres in Mumbai and three franchisees in Santacruz (Mumbai), Surat and Jaipur. Further we have also entered into a leave and license agreement for the opening of Gym in Thakur Complex, Kandivali (East) and interior work has commenced. As on date we have approximately 9000 members in all our gyms including our franchisees.

The Market Maker shall fulfill the applicable obligations and conditions as specified in the SEBI (ICDR) Regulations, and its amendments from time to time and the circulars issued by the BSE and SEBI regarding this matter from time to time.

As per clause (a) sub-regulation (1) Regulation 32 of the SEBI ICDR Regulations and in terms of the aforesaid table, an aggregate of 20% of the post-Issue Equity Share Capital of our Company shall be locked in by our Promoters for a period of three (3) years from the date of Allotment (“minimum Promoter’ contribution”).

The Promoters’ contribution has been brought in to the extent of not less than the specified minimum amount and has been contributed by the persons defined as Promoters under the SEBI ICDR Regulations. Our fund requirements and deployment thereof are based on the estimates of our management and have not been appraised by any bank or financial institution or independent third party entity. These are based on current circumstances of our business and are subject to change in light of changes in external circumstances or costs, or in our financial condition, business or strategy, as discussed further below and also detailed under the section 'Our Business' beginning on page 71 of the Prospectus. Our management, in response to the dynamic nature of the industry, will have the discretion to revise its business plan from time to time and consequently our funding requirement and deployment of funds may also change. This may also include rescheduling the utilization of Proceeds and increasing or decreasing expenditure for a particular object vis-à-vis the utilization of Proceeds. In case of a shortfall in the Net Proceeds, our management may explore a range of options which include utilisation of our internal accruals, debt or equity financing. Our management expects that such alternate arrangements would be available to fund any such shortfall.

Variation in fund requirements and Surplus / Shortfall of Net Proceeds

We intend to utilise the Issue Proceeds in the manner provided above, in the event of a surplus, we will use such surplus towards general corporate purposes including meeting future growth requirements. In case of any

variations in the actual utilization of funds earmarked for the above activities, increased fund deployment for a particular activity may be financed by surplus funds, if any, available in any other object for which funds are being raised in the Issue, subject to applicable law. In the event of any shortfall in the Issue Proceeds, our Company will bridge the fund requirements from internal accruals, debt or equity financing. In the event that estimated utilization out of the Net Proceeds in a Fiscal is not completely met, the same shall be utilized in the next Fiscal. No part of the issue proceeds will be paid as consideration to Promoters, Promoter Group, Group Entities, directors, Key Managerial Personnel and associates.

DETAILED BREAK UP OF THE PROJECT COST

B) OTHER GENERAL TAX BENEFITS TO THE COMPANY AND ITS SHAREHOLDERS

The following tax benefits shall be available to the Company and its Shareholders under Direct tax law **Under the Income-Tax Act, 1961 (,the Act’)**:

I. Benefits available to the Company

1. Depreciation

As per the provisions of Section 32 of the Act, the Company is eligible to claim depreciation on tangible and specified intangible assets as explained in the said section and the relevant Income Tax rules there under. In accordance with and subject to the conditions specified in Section 32(1) (ia) of the Act, the Company is entitled to an additional depreciation allowance of 20% of the cost of new machines acquired and put to use during a year.

2. Dividend Income

Dividend income, if any, received by the Company from its investment in shares of another domestic Company will be exempt from tax under Section 10(34) read with Section 115-O of the Income Tax Act, 1961.

3. Income from Mutual Funds / Units

As per section 10(35) of the Act, the following income shall be exempt in the hands of the Company:
Income received in respect of the units of a Mutual Fund specified under clause (23D) of section 10; or
Income received in respect of units from the Administrator of the specified undertaking; or
Income received in respect of units from the specified company.

However, this exemption does not apply to any income arising from transfer of units of the Administrator of the specified undertaking or of the specified company or of a mutual fund, as the case may be.

For this purpose (i) , Administrator’ mean the Administrator as referred to in section 2(a) of the Unit Trust of India (Transfer of Undertaking and Repeal) Act, 2002 and (ii) ,Specified Company’ means a company as referred to in section 2(h) of the said Act.

1. Income from Long Term Capital Gain

As per section 10(38) of the Act, long term capital gains arising to the Company from the transfer of a long-term capital asset, being an equity share in a company or a unit of an equity oriented fund where such transaction is chargeable to securities transaction tax would not be liable to tax in the hands of the Company.

For this purpose, ,Equity Oriented Fund’ means a fund –

- (i) Where the investible funds are invested by way of equity shares in domestic companies to the extent of more than sixty five percent of the total proceeds of such funds; and
- (ii) Which has been set up under a scheme of a Mutual Fund specified under section 10(23D) of the Act.

As per section 115JB, the Company will not be able to reduce the income to which the provisions of section 10(38) of the Act apply while calculating ,book profits’ under the provisions of section 115JB of the Act and will be required to pay Minimum Alternative Tax as follows-

5. Section 14A of the Act restricts claim for deduction of expenses incurred in relation to incomes which do not form part of the total income under the Act. Thus, any expenditure incurred to earn tax exempt income is not tax deductible.

6. As per the provisions of Section 112 of the Income Tax Act, 1961, long-term capital gains as computed above that are not exempt under Section 10(38) of the Income Tax Act, 1961 would be subject to tax at a rate of 20 percent (plus applicable surcharge plus education cess plus secondary and higher education cess). However, as per the provision to Section 112(1), if the tax on long-term capital gains resulting on transfer of listed securities or units, calculated at the rate of 20 percent with indexation benefit exceeds the tax on long-term capital gains computed at the rate of 10 percent without indexation benefit, then such gains are chargeable to tax at a concessional rate of 10 percent (plus applicable surcharge plus education cess plus secondary and higher education cess).

7. As per section 54EC of the Act and subject to the conditions and to the extent specified therein, long-term capital gains (in cases not covered under section 10(38) of the Act) arising on the transfer of a long-term capital asset will be exempt from capital gains tax if the capital gains are invested in a 'long term specified asset' within a period of 6 months after the date of such transfer. However, if the assessee transfers or converts the long term specified asset into money within a period of three years from the date of their acquisition, the amount of capital gains exempted earlier would become chargeable to tax as long-term capital gains in the year in which the long term specified asset is transferred or converted into money.

A 'long term specified asset' means any bond, redeemable after three years and issued on or after the 1st day of April 2006:

(i) by the National Highways Authority of India constituted under section 3 of the National Highways Authority of India Act, 1988, and notified by the Central Government in the Official Gazette for the purposes of this section; or

(ii) By the Rural Electrification Corporation Limited, a company formed and registered under the Companies Act, 1956, and notified by the Central Government in the Official Gazette for the purposes of this section.

8. As per section 111A of the Act, short-term capital gains arising to the Company from the sale of equity share or a unit of an equity oriented fund transacted through a recognized stock exchange in India, where such transaction is chargeable to securities transaction tax, will be taxable at the rate of 15% (plus applicable surcharge plus education cess plus secondary and higher education cess)

9. Preliminary Expenses

Under Section 35D of the Act, the company will be entitled to the deduction equal to 1/5th of the Preliminary expenditure of the nature specified in the said section, including expenditure incurred on present issue, such as Brokerage and other charges by way of amortization over a period of 5 successive years, subject to stipulated limits.

10. Credit for Minimum Alternate Taxes (MAT)

Under Section 115JAA (2A) of the Income Tax Act, 1961, tax credit shall be allowed in respect of any tax paid (MAT) under Section 115JB of the Income Tax Act, 1961 for any Assessment Year commencing on or after April 1, 2006. Credit eligible for carry forward is the difference between MAT paid and the tax computed as per the normal provisions of the Income Tax Act, 1961. Such MAT credit shall not be available for set-off beyond 10 years immediately succeeding the year in which the MAT credit initially arose.

II. Benefits to the Resident Shareholders of the Company under the Income-Tax Act, 1961:

1. As per section 10(34) of the Act, any income by way of dividends referred to in Section 115-O (i.e. dividends declared, distributed or paid on or after 1 April 2003) received on the shares of the Company is exempt from tax in the hands of the shareholders.

2. Section 48 of the Act, which prescribes the mode of computation of capital gains, provides for deduction of cost of acquisition/improvement and expenses incurred in connection with the transfer of a capital asset, from the sale consideration to arrive at the amount of capital gains. However, in respect of long-term capital gains, it offers a benefit by permitting substitution of cost of acquisition / improvement with the indexed cost of acquisition / improvement, which adjusts the cost of acquisition / improvement by a cost inflation index as prescribed from time to time.

3. Under Section 10(38) of the Income Tax Act, 1961, long-term capital gains arising to a shareholder on transfer of equity shares in the company would be exempt from tax where the sale transaction has been entered into on a recognized stock exchange of India and is liable to STT. However, the long-term capital gain of a shareholder being company shall be subject to income tax computation on book profit under section 115JB of the Income Tax, 1961.

4. Section 14A of the Act restricts claim for deduction of expenses incurred in relation to incomes which do not form part of the total income under the Act. Thus, any expenditure incurred to earn tax exempt income is not tax deductible.

5. As per section 112 of the Act, if the shares of the company are listed on a recognized stock exchange, taxable long-term capital gains, if any, on sale of the shares of the Company (in cases not covered under section 10(38) of the Act) would be charged to tax at the rate of 20% (plus applicable surcharge plus education cess plus secondary and higher education cess) after considering indexation benefits or at 10% (plus applicable surcharge plus education cess plus secondary and higher education cess) without indexation benefits, whichever is less.

6. As per section 54EC of the Act and subject to the conditions and to the extent specified therein, long-term capital gains (in cases not covered under section 10(38) of the Act) arising on the transfer of a long-term capital asset will be exempt from capital gains tax if the capital gains are invested in a 'long-term specified asset' within a period of 6 months after the date of such transfer. If only part of capital gain is so reinvested, the exemption shall be allowed proportionately provided that the investment made in the long-term specified asset during any financial year does not exceed fifty Lac rupees. In such a case, the cost of such long-term specified asset will not qualify for deduction under section 80C of the Act. However, if the assessee transfers or converts the long-term specified asset into money within a period of three years from the date of their acquisition, the amount of capital gains exempted earlier would become chargeable to tax as long-term capital gains in the year in which the long-term specified asset is transferred or converted into money. A 'long-term specified asset' means any bond, redeemable after three years and issued on or after the 1st day of April 2006: (i) by the National Highways Authority of India constituted under section 3 of the National Highways Authority of India Act, 1988, and notified by the Central Government in the Official Gazette for the purposes of this section; or (ii) By the Rural Electrification Corporation Limited, a company formed and registered under the Companies Act, 1956, and notified by the Central Government in the Official Gazette for the purposes of this section.

7. Under Section 54F of the Income Tax Act, 1961 and subject to the conditions specified therein, long-term capital gains (other than those exempt from tax under Section 10(38) of the Income Tax Act, 1961) arising to an individual or a Hindu Undivided Family ('HUF') on transfer of shares of the company will be exempt from capital gains tax subject to certain conditions, if the net consideration from transfer of such shares are used for purchase of residential house property within a period of 1 year before or 2 years after the date on which the transfer took place or for construction of residential house property within a period of 3 years after the date of such transfer.

8. Under Section 111A of the Income Tax Act, 1961 and other relevant provisions of the Income Tax Act, 1961, short-term capital gains (i.e., if shares are held for a period not exceeding 12 months) arising on transfer of equity share in the company would be taxable at a rate of 15 percent (plus applicable surcharge plus education cess plus secondary and higher education cess) where such transaction of sale is entered on a recognized stock exchange in India and is liable to STT. Short-term capital gains arising from transfer of shares in a Company, other than those covered by Section 111A of the Income Tax Act, 1961, would be subject to tax as calculated under the normal provisions of the Income Tax Act, 1961.

9. As per section 36(1)(xv) of the Act, the securities transaction tax paid by the shareholder in respect of taxable securities transactions entered in the course of the business will be eligible for deduction from the income chargeable under the head —Profits and Gains of Business or Profession if income arising from taxable securities transaction is included in such income.

III. Non-Resident Indians/Non-Resident Shareholders (Other than FIIs and Foreign Venture Capital Investors)

1. Dividend income, if any, received by the Company from its investment in shares of another domestic company will be exempt from tax under Section 10(34) read with Section 115-O of the Income Tax Act, 1961. Income, if any, received on units of a Mutual Funds specified under Section 10(23D) of the Income Tax Act, 1961 will also be exempt from tax under Section 10(35) of the Income Tax Act, 1961, received on the shares of the Company is exempt from tax.

2. As per section 10(38) of the Act, long-term capital gains arising to the shareholders from the transfer of a long-term capital asset being an equity share in the Company, where such transaction is chargeable to securities transaction tax would not be liable to tax in the hands of the shareholder.

3. Section 14A of the Act restricts claim for deduction of expenses incurred in relation to incomes which do not form part of the total income under the Act. Thus, any expenditure incurred to earn tax exempt income is not tax deductible.

4. A 'longterm specified asset' means any bond, redeemable after three years and issued on or after the 1st day of April 2006: (i) by the National Highways Authority of India constituted under section 3 of the National Highways Authority of India Act, 1988, and notified by the Central Government in the Official Gazette for the purposes of this section; or (ii) By the Rural Electrification Corporation Limited, a company formed and registered under the Companies Act, 1956, and notified by the Central Government in the Official Gazette for the purposes of this section.

5. Under Section 54F of the Income Tax Act, 1961 and subject to the conditions specified therein, long-term capital gains (other than those exempt from tax under Section 10(38) of the Income Tax Act, 1961) arising to an individual or a Hindu Undivided Family ('HUF') on transfer of shares of the Company will be exempt from capital gains tax subject to certain conditions, if the net consideration from transfer of such shares are used for purchase of residential house property within a period of 1 year before or 2 years after the date on which the transfer took place or for construction of residential house property within a period of 3 years after the date of such transfer.

6. Under Section 111A of the Income Tax Act, 1961 and other relevant provisions of the Income Tax Act, 1961, short-term capital gains (i.e., if shares are held for a period not exceeding 12 months) arising on transfer of equity share in the Company would be taxable at a rate of 15 percent (plus applicable surcharge plus education cess plus secondary and higher education cess) where such transaction of sale is entered on a recognized stock exchange in India and is liable to STT. Short-term capital gains arising from transfer of shares in a company, other than those covered by Section 111A of the Income Tax Act, 1961, would be subject to tax as calculated under the normal provisions of the Income Tax Act, 1961.

7. Under section 115-C (e) of the Act, the Non-Resident Indian shareholder has an option to be governed by the provisions of Chapter XIII A of the Act viz. 'Special Provisions Relating to Certain Incomes of Non-Residents' which are as follows:

(i) As per provisions of section 115D read with section 115E of the Act, where shares in the Company are acquired or subscribed to in convertible foreign exchange by a Non-Resident Indian, capital gains arising to the non-resident on transfer of shares held for a period exceeding 12 months, shall (in cases not covered under section 10(38) of the Act) be concessionaly taxed at the flat rate of 10% (plus applicable surcharge plus education cess plus secondary and higher education cess) (without indexation benefit but with protection against

foreign exchange fluctuation). (ii) As per section 115F of the Act, long-term capital gains (in cases not covered under section 10(38) of the Act) arising to a Non-Resident Indian from the transfer of shares of the company subscribed to in convertible foreign exchange shall be exempt from income tax, if the net consideration is reinvested in specified assets within six months from the date of transfer. If only part of the net consideration is so reinvested, the exemption shall be proportionately reduced. The amount so exempted shall be chargeable to tax subsequently, if the specified assets are transferred or converted into money within three years from the date of their acquisition. (iii) As per section 115G of the Act, Non-Resident Indians are not obliged to file a return of income under section 139(1) of the Act, if their only source of income is income from specified investments or long-term capital gains earned on transfer of such investments or both, provided tax has been deducted at source from such income as per the provisions of Chapter XVII-B of the Act. (iv) As per section 115H of the Act, where the Non-Resident Indian becomes assessable as a resident in India, he may furnish a declaration in writing to the Assessing Officer, along with his return of income for the assessment year in which he is first assessable as a Resident, under section 139 of the Act to the effect that the provisions of the Chapter XII-A shall continue to apply to him in relation to such investment income derived from the specified assets for that year and subsequent assessment years until such assets are converted into money. (v) As per section 115-I of the Act, a Non-Resident Indian may elect not to be governed by the provision of Chapter XII-A for any assessment year by furnishing his return of income for that assessment year under section 139 of the Act, declaring therein that the provisions of Chapter XIIA shall not apply to him for that assessment year and accordingly his total income for that assessment year will be computed in accordance the other provisions of the Act.

8. The tax rates and consequent taxation mentioned above shall be further subject to any benefits available under the Tax Treaty, if any, between India and the country in which the non-resident has fiscal domicile. As per the provisions of section 90(2) of the Act, the provisions of the Act would prevail over the provisions of the Tax Treaty to the extent they are more beneficial to the non-resident.

IV. Foreign Institutional Investors (FIIs)

1. Dividend income, if any, received by the Company from its investment in shares of another domestic company will be exempt from tax under Section 10(34) read with Section 115-O of the Income Tax Act, 1961. Income, if any, received on units of a Mutual Funds specified under Section 10(23D) of the Income Tax Act, 1961 will also be exempt from tax under Section 10(35) of the Income Tax Act, 1961 received on the shares of the Company is exempt from tax.

2. As per section 10(38) of the Act, long-term capital gains arising to the FIIs from the transfer of a long-term capital asset being an equity share in the Company or a unit of equity oriented fund where such transaction is chargeable to securities transaction tax would not be liable to tax in the hands of the FIIs.

3. As per section 115AD of the Act, FIIs will be taxed on the capital gains that are not exempt under the section 10(38) of the Act at the following rates:

Nature of Income	Tax Rate (%)
Long Term Capital Gain	10%
Short-Term Capital Gain (Referred to Section 111A)	15%
Short-Term Capital Gain (other than under section 111A)	30%

The above tax rates have to be increased by the applicable surcharge, education cess, and secondary and higher education cess.

4. In case of long-term capital gains, (in cases not covered under section 10(38) of the Act), the tax is levied on the capital gains computed without considering the cost indexation and without considering foreign exchange fluctuation.

5. As per section 54EC of the Act and subject to the conditions and to the extent specified therein, long-term capital gains (in cases not covered under section 10(38) of the Act) arising on the transfer of a long-term capital asset will be exempt from capital gains tax if the capital gains are invested in a 'long-term specified asset' within a period of 6 months after the date of such transfer. If only part of capital gain is so reinvested, the exemption shall be allowed proportionately provided that the investment made in the long-term specified asset during any financial year does not exceed fifty Lac rupees. In such a case, the cost of such long-term specified asset will not qualify for deduction under section 80C of the Act. However, if the assessee transfers or converts the long-term specified asset into money within a period of three years from the date of their acquisition, the

amount of capital gains exempted earlier would become chargeable to tax as long-term capital gains in the year in which the long-term specified asset is transferred or converted into money.

A 'long-term specified asset' means any bond, redeemable after three years and issued on or after the 1st day of April 2006: (i) by the National Highways Authority of India constituted under section 3 of the National Highways Authority of India Act, 1988, and notified by the Central Government in the Official Gazette for the purposes of this section; or (ii) By the Rural Electrification Corporation Limited, a company formed and registered under the Companies Act, 1956, and notified by the Central Government in the Official Gazette for the purposes of this section.

6. The tax rates and consequent taxation mentioned above shall be further subject to any benefits available under the Tax Treaty, if any, between India and the country in which the FII has fiscal domicile. As per the provisions of section 90(2) of the Act, the provisions of the Act would prevail over the provisions of the Tax Treaty to the extent they are more beneficial to the FII.

7. However, where the equity shares form a part of its stock-in-trade, any income realized in the disposition of such equity shares may be treated as business profits, taxable in accordance with the DTAA between India and the country of tax residence of the FII. The nature of the equity shares held by the FII is usually determined on the basis of the substantial nature of the transactions, the manner of maintaining books of account, the magnitude of purchases, sales and the ratio between purchases and sales and the holding etc. If the income realized from the disposition of equity shares is chargeable to tax in India as business income, FII's could claim, STT paid on purchase/sale of equity shares as allowable business expenditure. Business profits may be subject to applicable Tax Laws.

V. Venture Capital Companies/Funds

1. Under Section 10(23FB) of the Income Tax Act, 1961, any income of Venture Capital company / funds (set up to raise funds for investment in venture capital undertaking notified in this behalf) registered with the Securities and Exchange Board of India would be exempt from income tax, subject to conditions specified therein. As per Section 115U of the Income Tax Act, 1961, any income derived by a person from his investment in venture capital companies / funds would be taxable in the hands of the person making an investment in the same manner as if it were the income received by such person had the investments been made directly in the venture capital undertaking.

VI. Mutual Funds

1. As per Section 10(23D) of the Act, any income of Mutual Funds registered under the Securities and Exchange Board of India Act, 1992 or Regulations made there under, Mutual Funds set up by public sector banks or public financial institutions and Mutual Funds authorized by the Reserve Bank of India would be exempt from income tax, subject to such conditions as the Central Government may by notification in the Official Gazette specify in this behalf.

Under the Wealth Tax Act, 1957 Benefits to shareholders of the Company

Shares of the Company held by the shareholder will not be treated as an asset within the meaning of section 2 (ea) of Wealth Tax Act, 1957. Hence the shares are not liable to Wealth Tax.

Tax Treaty Benefits

An investor has an option to be governed by the provisions of the Income Tax Act, 1967 or the provisions of a Tax Treaty that India has entered into with another country of which the investor is a tax resident, whichever is more beneficial.

SECTION IV – ABOUT THE COMPANY

INDUSTRY OVERVIEW

Indian Fitness & Slimming Industry constitutes about 8% of the wellness market. Presently, the fitness industry is in its nascent stages. The industry is fairly fragmented since the majority of the market appears to be dominated by a large number of mom-and-pop gyms. Organized fitness services account for merely 25% of the overall fitness industry.

The Indian Fitness & Slimming Industry is set to ride high with all levers in place. Growing disposable income of the people coupled with rising awareness of a healthy body augur well for the Industry. Significant changes in lifestyle related to lack of physical activity and increased consumption of fast food among both affluent and working class population has led to greater need for healthy lifestyles. Indian fitness & slimming industry currently pegged at USD 0.78 billion is stated to grow at a CAGR of 25% to reach USD 2.4 Billion by 2015. We would not be surprised if the industry outperforms our ballpark figure.

The fitness industry is highly under penetrated in India with mere 0.4% (taken for top 7 cities) membership as compared to Asia Pacific average of 3.7%. The industry, as a whole, is expected to benefit from rising proportion of age group between 20 and 44 in India, which is expected to be ~40% of India's total population by the end of 2016. In addition, growing disposable incomes and rising lifestyle related diseases would pent up demand for quality health and fitness services.

The Indian wellness industry encompasses a large number of service segments including beauty services (salon, treatment based beauty products), personal health counselling, fitness and rejuvenation segments. The current size of the overall Indian wellness industry is estimated at ~ 49,000 crore. The industry comprises beauty services and cosmetics products, which is estimated at ~20,000 crore. The fitness and slimming market is estimated at ~4,000 crore, nutrition market (includes health and wellness food and beverages) at ~13,000 crore, rejuvenation at ~500 crore and alternate therapy market in India at ~11,500 crore, respectively. Further, according to the Ficci-PwC knowledge report, the Indian wellness industry is expected to grow at a CAGR of 20% for the next three years to reach around 87,500 crore on the back of rising disposable incomes and increasing need to 'look good' among the youth population in India.

We expect the major growth driver for the fitness service industry to be the growing population in urban India. According to census 2011 provisional data, the urban population constituted 31.2% of the total population in 2011. There has been continuous growth in disposable income from 2001-02 to 2009-10. It suggests that the number of households earning below 1.4 lakh per annum declined from 135 million to 114 million in 2009-2010. However, the number of households earning between 3.1 lakh and 15.6 lakh in each segment grew at ~12% CAGR (from 11 million to 28 million) between 2001-02 and 2009-10. With rising income levels, we expect spending to also increase significantly. During the last few years, a sharp rise in wealth can be seen in several posh residential complexes that have emerged in the top few Indian cities like Mumbai, NCR, Chennai, Kolkata, Hyderabad, Bangalore and Pune. This segment of the population provides an upscale market for fitness centres to offer not just the basic gym facility but also advanced value added activities like spas, steam/sauna bath, nutrition centres, aerobics, spinning studios and personal training programmes.

Significant changes in lifestyle related to lack of physical activities and increased consumption of "junk foods" among the young population has created a greater need for a healthy lifestyle through exercise and counselling on dietary habits. According to the International Diabetic Federation, India alone has 61.3 million people living with diabetes. This places India second only to China. Due to its large child population, India accounts for most of the 1,12,000 children with type 1 diabetes. Rising number of diabetic patients in India in the adult age group is creating room for established gyms players to expand gyms with trained employees.

There is a growing demand for wellness services in urban markets beyond Tier 1 cities mainly due to rising awareness in the country on diseases like diabetes. A study of AC Nielsen's Global Online Consumer Survey 2009 reveals that going to gym is the second most preferred option for exercise after walking. Among total respondents, ~35% preferred exercise through walking while only 18% preferred gyms for the exercise. We expect penetration of gyms to increase in the near future with rising income level and awareness about lifestyle diseases among the adult age group.

The gym, health and fitness clubs industry is in the growth stage of its life cycle due to an increased awareness and interest in fitness & health and the need for exercise. Even in the midst of the economic downturn, the industry has maintained steady growth, with membership rates growing consistently and profits remaining solid. Demand for gyms and health and fitness clubs will continue to rise over the next five years as the general public becomes more health conscious and the aging population places a greater emphasis on staying fit. Additionally, the amount of leisure time and growth in household incomes will positively affect businesses, leading operators to expand into larger facilities.

Levels of services and offerings

Health clubs offer many services, and as a result the monthly membership prices can vary greatly. Costs can vary through the purchase of a higher-level membership, such as a Founders or a Life membership. Such memberships often have a high up-front cost but a lower monthly rate, making them potentially beneficial to those who use the club frequently and hold their memberships for years.

A fitness centre or a gym usually consists of the following facilities:

Main workout area

Most health clubs have a main workout area, which primarily consists of free weights including dumbbells, barbells and exercise machines. This area often includes mirrors so that exercisers can monitor and maintain correct posture during their workout. A gym which predominately or exclusively consists of free weights (dumbbells and barbells), as opposed to exercise machines, is sometimes referred to as a black-iron gym, after the traditional color of weight plates.

Cardio area/Theatre

A cardio theater or cardio area includes many types of cardiovascular training-related equipment such as rowing machines, stationary exercise bikes, elliptical trainers and treadmills. These areas often include a number of audio-visual displays (either integrated into the equipment, or placed on walls around the area itself) in order to keep exercisers entertained during long cardio workout sessions

Sports facilities

Some health clubs offer sports facilities such as a swimming pools, squash courts or boxing areas. In some cases, additional fees are charged for the use of these facilities.

Personal training

Most health clubs employ personal trainers who are accessible to members for training/fitness/nutrition/health advice and consultation. Personal trainers can devise a customized fitness routine, sometimes including a nutrition plan, to help clients achieve their goals. They can also monitor and train with members. More often than not, access to personal trainers involves an additional hourly fee.

Other services

Newer health clubs generally include health-shops, snack bars, restaurants, child-care facilities, member lounges and cafes. It is not unusual for a sauna, steam shower, or wellness areas to be present. Health clubs generally charge a fee to allow visitors to use the equipment, courses, and other provided services. A fairly new trend is the advent of eco friendly health clubs which incorporate principles of "green living" in its fitness regimen.

Group exercise classes

Most newer health clubs offer group exercise classes that are conducted by certified fitness instructors. Many types of group exercise classes exist, but generally these include classes based on aerobics, cycling (spin cycle), boxing or martial arts, high intensity training, step, regular and hot (Bikram) yoga, pilates, muscle training, and self-defense classes such as Krav Maga and Brazilian jiu-jitsu. Health clubs with swimming pools often offer aqua aerobics classes. The instructors often must gain certification in order to teach these classes and ensure participant safety

Conclusion

The wellness industry in India is poised to touch Rs 1,00,000 crore (Rs 1 trillion) by 2015, with a compounded annual growth rate of 15-17%, from about Rs 70,000 crore in 2012. Of the entire wellness industry, beauty care would continue to dominate with almost 50% (about Rs 49,000 crore), followed by alternate therapy (about Rs 21,000 crore) and health and wellness food and beverages at about Rs 27,000 crore, according to the study.

The size of the beauty care industry is estimated at Rs 29,000 crore in 2012 estimate, while fitness and slimming market was estimated at Rs 60,000 crore in 2012. About 60% of the market is dominated by products. However, the industry is facing issues in getting standard skilled manpower, and no standard is followed across the industry.

Unless the context otherwise requires, in relation to business operations, in this section of the Prospectus, all references to "we", "us", "our" and "our Company" are to Powerhouse Fitness And Realty Limited and Group Entities as the case may be.

Overview

We are a fitness chain operating in Mumbai and also have the presence in Surat and Jaipur through our franchise. We operate our Gyms under the brand "Powerhouse Gyms" which is owned by Powerhouse Gyms International headquartered in Detroit, USA.

Our Gyms are state of the art facilities with services including gyms, steam, aerobics and diet counseling amongst others.

The first gym was established in May 1999, as "Q's Fitness Studio" a proprietary firm with Mr. Ashok Gupta HUF as its sole proprietor at Santacruz West, Mumbai. After the success of the Santacruz centre another centre was set up at Vile Parle, Mumbai in October 2004.

"Q's Fitness Studio" has signed a Master Licensing Agreement dated March 21, 2005 with Powerhouse Licensing LLC, which provides us with the exclusive right to set up and operate Powerhouse Gyms and to use and license of the Powerhouse Gyms and the associated trademarks in the gyms in India, Nepal, Bangladesh and Sri Lanka set up and run Powerhouse gyms in India, Sri Lanka, Nepal, Bangladesh and Maldives. The first Powerhouse fitness centre in India was set up in November 2005 at at Juhu (Mumbai). The centres at Santacruz and Vile Parle were converted to Powerhouse.

We receive strong support from the management Powerhouse Gym USA in areas such as space planning, equipment selection, demographic information, staffing requirements, marketing information, discounts from vendors etc.

In February 2013, our Company, Powerhouse Fitness & Realty Limited was incorporated to consolidate the business and bring all the gyms into a single entity. Currently, we have 13 Powerhouse Gyms in Mumbai located at Juhu, Vile Parle, Chembur, Ghatkopar, Mulund(W), Chowpatty, Prabhadevi, Andheri(E), 4 Bungalows, Malad (W), Mumbai Central and Colaba. Our gyms are generally located in neighbourhood markets in Mumbai.

Currently, our Company operates 13 fitness centres in Mumbai and three franchisees in Santacruz (Mumbai), Surat and Jaipur. Further we have also entered into a leave and license agreement for the opening of Gym in Thakur Complex, Kandivali (East) and interior work has commenced. As on date we have approximately 9000 members in all our gyms including our franchisees.

Powerhouse Brand

Powerhouse Licensing LLC, a Michigan limited liability company has rights to the trademark "Powerhouse Gym". Powerhouse Gyms International is headquartered in Detroit, USA. "Q's Fitness Studio" has signed a Master Licensing Agreement dated March 21, 2005 with Powerhouse Licensing LLC, which provides Q's Fitness Studio with the exclusive right to set up and operate Powerhouse Gyms and to use and license of the Powerhouse Gyms and the associated trademarks in the gyms in India, Sri Lanka, Nepal, Bangladesh and Maldives. The agreement is for the period of 10 years w.e.f. March 18, 2005. Subsequently in October 2009, Q's Fitness Studio entered into an addendum agreement wherein it was agreed to grant 5 year extension upon

payments being brought current. We have been authorised by Q's Fitness Studio to use the brand Powerhouse Gyms in our Company without any compensation.

OUR SERVICES AND PROCESSES

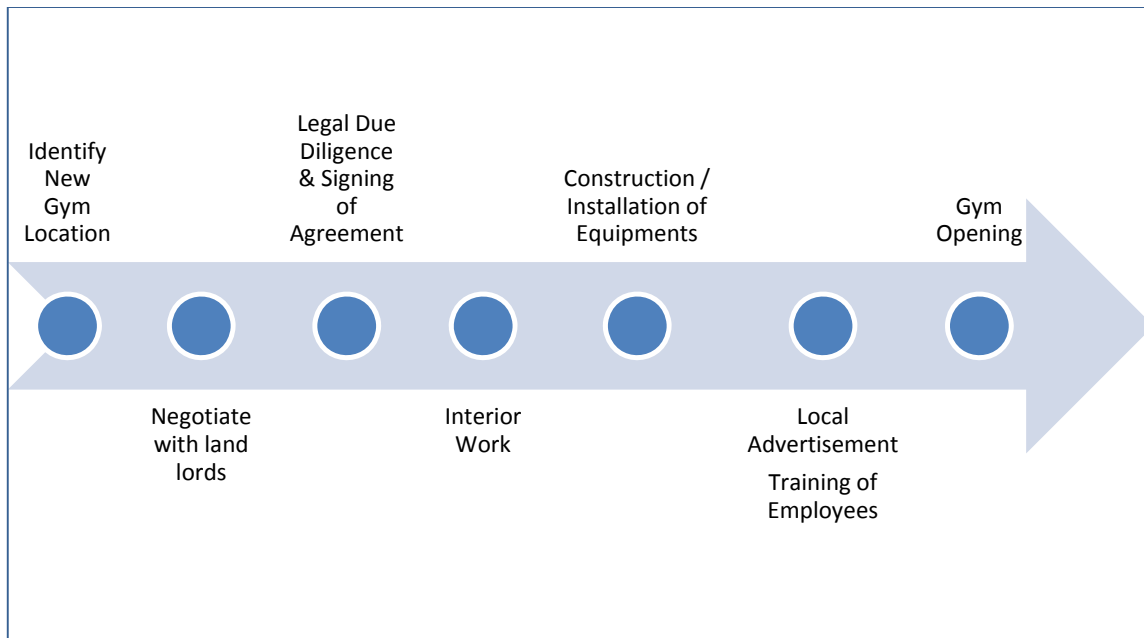
Our Company operates 13 fitness centres in Mumbai and three franchisees in Santacruz (Mumbai), Surat and Jaipur. Our Gyms are state of the art facilities and provide services including gyms, steam, aerobics and diet counseling amongst others to our clients. We place emphasis on ensuring that we procure high-quality materials and equipment, enabling us to provide quality services in an attractive environment to our customers. We are further planning to open 6 new gyms in Mumbai.

Gym Management

For our network of Gyms in Mumbai operated by us, we also maintain profit and loss statements at the gym level for internal purposes. All costs attributable to a gym are charged at the gym-level and the gym manager has discretion to take actions in order to increase sales or reduce costs. Our managers, are responsible for maintaining the records of cash flow, sales and expenses and the performance of their respective gyms. We place great emphasis on training our employees as they act as the most critical link to our customers. We have an internal training for all gym employees.

Project Management

We have developed a new gym selection process that takes into consideration various factors such as area, household count, presence of corporates, location visibility, and presence of competition that would enable us to operate the gyms in a profitable manner. Our internal management team under the leadership of our Executive Directors ensure that we purchase standardised equipment from selected vendors. We plan in detail our procurement of equipments prior to lease signing as well designing standardised processes for all functions related to gym opening, which enables us to reduce our gym opening time to between 40-60 days on average from the date of possession of premises for a new gym location.

Competition

We operate in a highly competitive market and face stiff competition from other players operating both in organized and un-organized sectors. Some foreign players have also entered the Indian market. Pricing is one of the factors that play an important role in our customers’ selection of our services. There are several strategies adopted by our competitors to increase their market share i.e. through advertising, pricing, service and new product introductions among others. This increased competition by both traditional and new players may affect our margins. In order to protect our existing market share or capture market share, we may be required to increase expenditure for advertising and promotions and to introduce and establish new products. Due to inherent risks in the marketplace associated with advertising and new product introductions, including uncertainties about consumer response, increased expenditure may not prove successful in maintaining or enhancing our market share and could result in lower profitability.

We use Print, Radio, Hoarding, Banners etc. Our Company plans brand building through media advertising. Future Prospects

Presently, the fitness industry is in its nascent stages. The industry is fairly fragmented since the majority of the market appears to be dominated by a large number of mom-and-pop gyms. This high degree of fragmentation, lack of product differentiation, and customer price sensitivity result in prevalent price competition and low margins. The market also appears to have a shortage of talent, since qualified personal trainers, nutrition consultants and professional managers are scarce, which also contributes to the lack of differentiation. Yet, on the other hand, awareness about fitness and a healthy lifestyle is growing; along with higher disposable incomes and a growing young population. India presents a huge opportunity for the health and fitness industry.

The first gym was established in May 1999, as “Q’s Fitness Studio” a proprietary firm with Mr. Ashok Gupta HUF as its sole proprietor at Santacruz West, Mumbai. After the success of the Santacruz centre another centre was set up at Vile Parle, Mumbai in October 2004.

“Q’s Fitness Studio” has signed a Master Licensing Agreement dated March 21, 2005 with Powerhouse Licensing LLC, which provides us with the exclusive right to set up and operate Powerhouse Gyms and to use and license of the Powerhouse Gyms and the associated trademarks in the gyms in India, Nepal, Bangladesh and Sri Lanka set up and run Powerhouse gyms in India, Sri Lanka, Nepal, Bangladesh and Maldives. The first Powerhouse fitness centre in India was set up in November 2005 at at Juhu (Mumbai). The centres at Santacruz and Vile Parle were converted to Powerhouse.

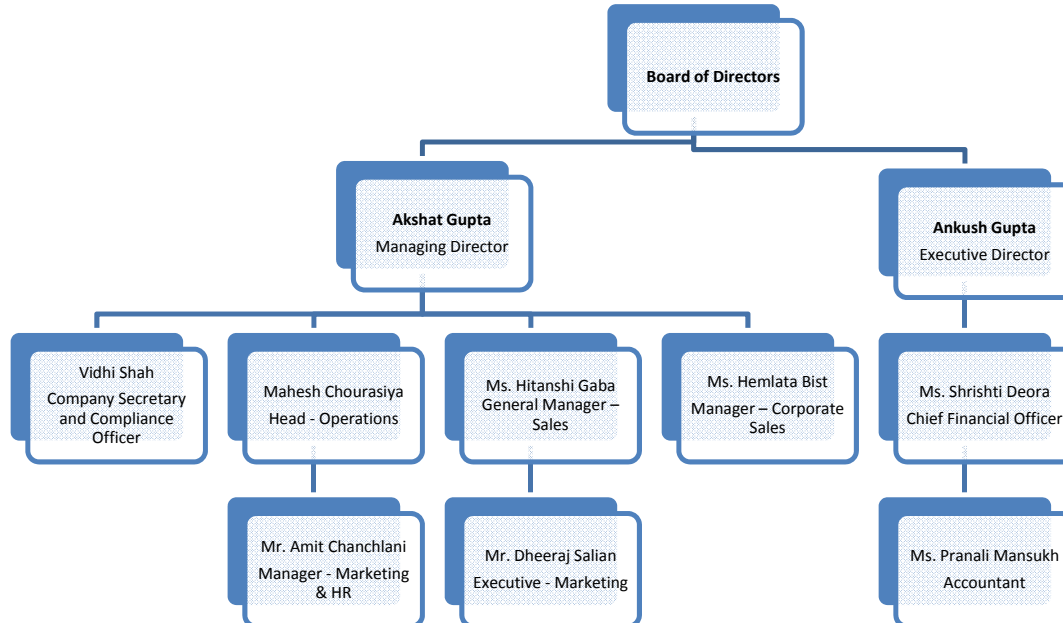

SIGNIFICANT ACCOUNTING POLICIES -

1. Basis of Preparation of Financial Statements:

The Restated Financial Statements have been prepared under Historical Cost conventions and on accrual basis in accordance with the Generally Accepted Accounting Principles ('GAAP') applicable in India Companies (Accounting Standard) Rules 2006 notified by Ministry of Company Affairs and Accounting Standards issued by the Institute of Chartered Accountants of India as applicable and relevant provisions of the Companies Act 1956 as adopted consistently by the Company.

2. Use of Estimates:

The presentation of financial statements in conformity with the generally accepted accounting principles requires estimates and assumptions to be made that affect the reported amount of assets and liabilities on the date of the financial statements and the reported amount of revenue and expenses during the reported period. Differences between the actual result and estimates are recognized in the period in which the results are known/materialize.

3. Fixed Assets:

Fixed Assets are stated at cost of acquisition less accumulated depreciation thereon. Fixed Assets are accounted at cost of acquisition inclusive of inward freight duties taxes and other incidental expenses related to acquisition and installation of Fixed Assets incurred to bring the assets to their working condition for their intended use.

4. Depreciation:

Depreciation is provided for in the books on written down value method as per the rates prescribed under Schedule XIV of the Companies Act 1956.

5. Investments:

Investments that are readily realisable and intended to be held for not more than a year are classified as current investments. All other investments are classified as long term investments. Current investments are carried at lower of the cost and fair value determined on an individual item basis. Long term investments are carried at cost. However, provision for diminution in value is made to recognize a decline other than temporary in nature.

6. Revenue Recognition:

Revenues are recognized and expenses are accounted on accrual basis with necessary provisions for all known liabilities and losses. Dividend income is recognized when right to receipts is established. Profit or loss on sale of securities is accounted on trade date basis. Other Income has been recognized on the basis of Accounting Standard

8. Borrowing Cost:

Borrowing Costs that are directly attributable to the acquisition or production of qualifying assets are capitalized as the cost of the respective assets. Other Borrowing Costs are charged to revenue.

9. Retirement Benefits:

The liability for gratuity has not been provided as per the provisions of Payment of Gratuity Act, 1972 since no employee of the company is eligible for such benefits during the year.

In respect of Leave Salary, the same is accounted as and when the liability arises in accordance with the provision of law governing the establishment.

10. Accounting of taxes on Income:

Tax expenses for the year comprise of current tax and deferred tax.

Current tax is measured after taking into consideration the deductions and exemptions admissible under the provision of Income Tax Act 1961.

Deferred Tax assets or liabilities are recognized for further tax consequence attributable to timing difference between taxable income and accounting income that are measured at relevant enacted tax rates and in accordance with Accounting Standard 22 on “Accounting for Taxes on Income” issued by ICAI. At each Balance Sheet date the Company reassesses unrecognized deferred tax assets to the extent they become reasonably certain or virtually certain of realization as the case may be.

11. Leased Assets:

The Company’s significant Leasing arrangements are in respect of Operating leases for premises which are cancellable in nature. The Lease rentals paid under such Agreements are charged to Profit and Loss Account.

12. Provisions and Contingent Liabilities:

The Company recognizes a provision when there is a present obligation as a result of a past event that probably requires an outflow of resources and a reliable estimate can be made of the amount of the obligation. A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may but probably will not require an outflow of resources. Where there is a possible obligation or a present obligation that the likelihood of outflow of resources is remote no provision or disclosure is made.

13. Impairment of Assets:

The Company assesses at each balance sheet date whether there is any indication that an assets may be impaired. If any such indication exists the Company estimates the recoverable amount of the asset. If such recoverable amount of the asset or recoverable amount of the cash generating unit to which the assets belongs is less than the carrying amount the carrying amount is reduced to its recoverable amount. The reduction is treated as impairment loss and is recognized in the profit and loss account. If at the balance sheet date there is an indication that if a previously assessed impairment loss no longer exists the recoverable amount is reassessed and the assets is reflected at the recoverable amount.

MANAGEMENT’S DISCUSSION AND ANALYSIS OF FINANCIAL CONDITIONS AND RESULTS OF OPERATIONS

You should read the following discussion of our financial condition and results of operations together with our restated financial statements included in the Prospectus. You should also read the section entitled “Risk Factors” beginning on page 10, which discusses a number of factors, risks and contingencies that could affect our financial condition and results of operations. The following discussion relates to our Company and, is based on our restated financial statements, which have been prepared in accordance with Indian GAAP, the Companies Act and the SEBI Regulations. Portions of the following discussion are also based on internally prepared statistical information and on other sources.

Business Overview

We are a fitness chain operating in Mumbai and also have the presence in Surat and Jaipur through our franchise. We operate our Gyms under the brand “Powerhouse Gyms” which is owned by Powerhouse Gyms International headquartered in Detroit, USA.

Our Gyms are state of the art facilities with services including gyms, steam, aerobics and diet counseling amongst others.

The first gym was established in May 1999, as “Q’s Fitness Studio” a proprietary firm with Mr. Ashok Gupta HUF as its sole proprietor at Santacruz West, Mumbai. After the success of the Santacruz centre another centre was set up at Vile Parle, Mumbai in October 2004.

“Q’s Fitness Studio” has signed a Master Licensing Agreement dated March 21, 2005 with Powerhouse Licensing LLC, which provides us with the exclusive right to set up and operate Powerhouse Gyms and to use and license of the Powerhouse Gyms and the associated trademarks in the gyms in India, Nepal, Bangladesh and Sri Lanka set up and run Powerhouse gyms in India, Sri Lanka, Nepal, Bangladesh and Maldives. The first Powerhouse fitness centre in India was set up in November 2005 at at Juhu (Mumbai). The centres at Santacruz and Vile Parle were converted to Powerhouse.

In February 2013, our Company, Powerhouse Fitness & Realty Limited was incorporated to consolidate the business and bring all the gyms into a single entity. We have been authorised by Q’s Fitness Studio to use the brand ‘Powerhouse Gym’ for our business in India. Currently, we have 12 Powerhouse Gyms in Mumbai located at Juhu, Vile Parle, Chembur, Ghatkopar, Mulund(W), Chowpatty, Prabhadevi, Andheri(E), 4 Bungalows, Malad (W) & Bombay Central. Our gyms are generally located in neighbourhood markets in Mumbai.

Currently, our Company operates 13 fitness centres in Mumbai and three franchisees in Santacruz (Mumbai), Surat and Jaipur. Further we have also entered into a leave and license agreement for the opening of Gym in Thakur Complex, Kandivali (East) and interior work has commenced. As on date we have approximately 9000 members in all our gyms including our franchisees.

Significant developments subsequent to the last financial year:

After the date of last financial year i.e. March 31, 2014, the Directors of our Company confirms that, there have not been any significant material developments.

Key factors affecting the results of operation:

Our Company’s future results of operations could be affected potentially by the following factors:

Competition

We primarily face competition from companies which offer similar products. The major brands with which we compete in the fitness industry include Golds Gym, Leena Mogre Fitness, Talwalkar’s amongst others. We anticipate this competition to grow as the demand and awareness for fitness increases and we also expect additional companies to enter the Indian market. As our Company enter newer markets, we are likely to face additional competition from those who may be better capitalized, have longer operating history, have greater

brand presence, and better management than us. If we are unable to manage our business it might impede our competitive position and profitability.

Growth in the Indian economy

General economic conditions in India have a significant impact on our results of operations. The Indian economy has grown rapidly over the past decade and is expected to continue to grow in the future. As a result, real average household incomes have roughly doubled since 1985. There has been an overall increase in the awareness about the health and fitness in urban India and this has directly benefited the fitness industry..

Brand Image

Our success depends on our ability to maintain the brand image of our existing products and effectively enhancing the brand image for new products and brand extensions. Product quality issues, real or imagined, or allegations of product & services defects, even when false or unfounded, could tarnish the image of the established brands and may cause consumers to choose other products.

Regulatory developments

Our Company is regulated by the Companies Act and some of its activities are subject to supervision and regulation by statutory and regulatory authorities. It is therefore subject to changes in Indian law, as well as to changes in regulation and government policies and accounting principles.

Discussion on Results of Operation:

The following discussion on results of operations should be read in conjunction with the audited financial results of our Company for the period from February 8, 2013 and ended on March 31, 2014.

Operating Income

We recorded operating income of ₹ 383.56 Lacs. Our operating income consists of membership fees charged to our members for the use of Gym and other fitness facilities provided by us. We had other income of ₹ 5.92 Lacs. Total income for the period ended March 31, 2014 stood at ₹ 389.48 Lacs.

Operating Expenses

The total operating expenditure aggregated to ₹ 340.30 Lacs which was 87.37% of the total income.

We incurred administrative expenses of ₹ 213.10 Lacs which was 62.62% of the total operating expenses and 54.71% of the total income. Administrative expenses consist of commission, electricity expenses, office rent, general and marketing expenses amongst others.

Employee Benefit Expenses stood at ₹ 127.20 Lacs which was 37.38% of the total operating expenses and 32.66% of the total income. Employee benefit expenses consist of salaries and other employee welfare expenses.

Depreciation

We incurred Depreciation cost of ₹ 17.26 Lacs, which was 4.43% of our total income.

Interest and Financial Charges

Our financial charges for the period ended March 31, 2014 stood at ₹ 19.63 Lacs, which was 5.04% of our total income. It mainly consists of interest on secured bank loans.

Profits

Our PBIDT stood at ₹ 49.18 Lacs for the period ended March 31, 2014 with the PBIDT margin of 12.63%. We recorded PBT of ₹ 12.29 Lacs and PBT margin stood at 3.16%. We recorded Net Profit of ₹ 8.29 Lacs. Our Net Profit Margin stood at 2.13%.

Related Party Transactions: For further information please refer “Annexure XV” beginning on page 119 under Chapter titled “Auditors’ Report and Financial Information of our Company” beginning on page 106 of the Prospectus.

Financial Market Risks: We are exposed to financial market risks from changes in borrowing costs, interest rates and inflation.

Interest Rate Risk: Our Company is currently exposed to interest rate risks to the extent of loans outstanding. Any further future borrowings may increase the risk.

Effect of Inflation: We are affected by inflation as it has an impact on the operating cost, staff costs etc. In line with changing inflation rates, we rework our margins so as to absorb the inflationary impact.

FACTORS THAT MAY AFFECT THE RESULTS OF THE OPERATIONS:

1. Unusual or infrequent events or transactions

To our knowledge there have been no unusual or infrequent events or transactions that have taken place during since incorporation.

2. Significant economic changes that materially affected or are likely to affect income from continuing operations.

Our business has been subject, and we expect it to continue to be subject, to significant economic changes arising from the trends identified above in ‘Factors Affecting our Results of Operations’ and the uncertainties

described in the section entitled ‘*Risk Factors*’ beginning on page 10 of the Prospectus. To our knowledge, except as we have described in the Prospectus, there are no known factors which we expect to bring about significant economic changes.

3. Known trends or uncertainties that have had or are expected to have a material adverse impact on sales, revenue or income from continuing operations.

Apart from the risks as disclosed under Section titled “Risk Factors” beginning on page 10 in the Prospectus, in our opinion there are no other known trends or uncertainties that have had or are expected to have a material adverse impact on revenue or income from continuing operations.

We have further sent a Mutual Discussion Notice for resolution of disputes dated August 13, 2014 to mutually arrive at a resolution of disputes/ issues between the Parties. The matter is pending

II. Litigations involving our Directors / Promoter

A. *Against our Directors / Promoter:*

a) **Legal Notice dated February 07, 2014 from Mr. Dilip P. Bedi**

Mr. Dilip P. Bedi, Advocate High court has sent legal notice on behalf of his client Mr. Rajesh Kapoor, Ex-director of SVC Resources Limited to Mr. Akshat Gupta and Mr. Ashok Gupta as directors of SVC Resources Limited for alleged defamation of his client by publishing defamatory and false information about him on BSE website. The notice is given to withdraw the alleged defamatory article and publish apology on the official website of BSE within 15 days of receipt of the legal notice. Mr. Ashok Gupta has replied to above notice vide letter dated February 22, 2014. There is no further correspondence on the matter.

b) **C. A. No. 13 of 2014 in C. P. No. 31(MUM) of 2013 before Company Law Board**

Mohit Khullar and others have filed an application dated March 18, 2014 before Company Law Board (CLB), New Delhi praying for initiating the contempt proceedings against the SVC Resources Limited, Mr. Ashok Gupta, Mr. Akshat Gupta, Mrs. Sushma Gupta and others for breach of orders of Hon'ble CLB dated January 23, 2014 and that the Observer's Report on the EOGM dated January 11, 2014 may be implemented and the new Board be allowed to take charge of the affairs/ management of the Company. Hon'ble CLB, New Delhi Bench vide order dated April 04, 2014 allowed the C. A. No. 13 of 2014 and directed SVC Resources Limited to implement the resolution passed in EOGM dated January 11, 2014 in toto. The existing board was superseded by the BoD appointed in the EOGM. The matter is pending for final hearing on July 9, 2014.

Meanwhile, Mr. Mohit Khullar and others filed appeal in the Honorable High Court with a prayer to call EOGM as per the requisition notice u/s 169(7) of the Companies Act, 1956 dated April 3, 2013. Pursuant to said appeal the high court passed order on August 14, 2013, August 26, 2013 and September 4, 2013 wherein the Hona High Court has recoded the undertaking given by the then MD Mr. Ashok Gupta that the status quo as of today in respect of shareholding will be maintained until the further order. The statement is accepted as an undertaking given in the court.

The next date of hearing is 12th September, 2014.

c) **Company Appeal No. 10 of 2014 before Company Law Board**

SVC Resources Limited and Mr. Mohammed Ali, Managing Director of SVC Resources Limited, have filed Petition u/s. 111A (3) of the Companies Act 1956 dated April 23, 2014 against the Mr. Ashok

Gupta, Mr. Akshat Gupta, Mrs. Sushma Gupta and others before Company Law Board (CLB), Mumbai Bench seeking reliefs as under :

1. Declare the allotment of 1,08,44,426 equity shares on 08.05.2013 to be illegal and void and cancel the shares allotted as per the said announcement to Sushma Gupta and Ashok Gupta, Ashok Gupta HUF, Sushanku Enterprise Ltd., Ashok B. Gupta, Akshat. A. Gupta, Ashok Gupta.
2. Declare the allotment of 2,97,00,000 equity shares on 05.08.2013 to be irregular and void and cancel the shares allotted as per the said announcement to M/s. Subhtex India Limited.
3. direct rectification of the Register of Members of the Company.
4. direct the old Board of Directors, through Respondent No. 1 (ex-managing Director) to handover the information and documents related to the Company to new Managing Director of the Company.
5. to stop the 3 directors viz. Ms. Neha Kiran Gandhi, Mr. Divesh Kohli and Mrs. Shrishti Suresh Deora from holding any meeting and giving any outcome until their appointment is confirmed by the members.

Applicants have also seek Interim Reliefs as under:

3. Restrain respondents and promoters from investing, selling, disposing off, encumbering or alienating any of the shares allotted as per announcements dated 08.05.2013 and 05.08.2013.
4. Direct the ROC, Mumbai to upload names of new Board of Directors in place of existing directors in compliance with order dated 04.04.2014 of the CLB, Principal Bench, New Delhi.

The next date of hearing is 12th September, 2014.

Meanwhile SVC Resources Limited and Mr. Mohammed Ali, Managing Director of SVC Resources Limited, have filed C. A. No. 130 of 2014 in **Company Appeal No. 10 of 2014 before Company Law Board, Mumbai** to transfer the above Company petition to CLB, New Delhi Bench as another Company Petition being C. P. No. 31 of 2013 is pending before that bench for hearing and disposal.

d) Complaint against Akshat Ashok Gupta in the C.C. No. 1001434/PS of 2012

Juhu Police station has registered a FIR no. 3197 for offence under Section 185 of Motor Vehicle Act bearing C.C. No. 1001434/PS of 2012 against Akshat Ashok Gupta in 10th Court of Metropolitan Magistrate, Mumbai.

The case is compounded and disposed off by the court.

e) Complaint under Section 138 of the Negotiable Instruments Act bearing C.C. No. 37/2013

M/s. Prudent Fintrade Pvt. Ltd. had filed a Complaint under Section 138 of the Negotiable Instruments Act bearing C.C. No. 37/2013 against Mr. Akshat Ashok Gupta for cheque bouncing. Both the parties have filed a compromise before the Hon'ble Metropolitan Magistrate Court no. 33 of Ahmedabad in the C.C. No. 37/2013 and agreed to settle the dispute out of the Court for full and final settlement amount of Rs.24,50,000/-. As per the terms of settlement, Mr. Akshat Ashok Gupta has paid Rs.19,00,000 till date.

f) SEBI Notice dated June 02, 2014 to Santowin Corporation limited

SEBI vide notice dated June 02, 2014 under rule 4 of SEBI (Procedure for holding inquiry and imposing penalties by Adjudicating Officer) Rules, 1995 read with section 15I of SEBI Act, 1992 has alleged that Santowin Corporation limited has provided wrong and misleading information to SEBI regarding the disclosure of acquisition of shares of Santowin by one of the promoter of our Company Mr. Akshat Gupta. It was also alleged that Santowin has violated Regulation 13(6) of SEBI

(Prohibition of Insider Trading) Regulations, 1992 regarding disclosure of above acquisition to stock exchange i.e. BSE. SEBI has called upon Santowin to showcause why an inquiry should not be held against it for above violations. Santowin has replied to SEBI vide letter dated June 25, 2014. Further MR. Ashok Gupta, Director of Santowin Corporation Limited had attended the SEBI office and seek adjournment and subsequently sent the mail confirmation for adjournment vide email dated August 21, 2014.

The next date of hearing is awaited.

1. Complaint for registering FIR u/s. 156(3) CPC against Pranidhi Commerce Private Limited and others

Mr. Akshat A. Gupta has filed a complaint before the Additional Metropolitan Magistrate Court at Mumbai dated April 09, 2013 to direct Azad Maidan Police Station to register FIR as per section 156(3) of Criminal Procedure Code for offences committed as per section 383, 468, 469, 500, 503, 120 (B), read with 34 of Indian Penal Code against Pranidhi Commerce Private Limited, its Directors viz. Pramod Jain, Sahib Singh Gusain, Lalit Gupta and Plus Corporate Ventures Private Limited, its Director viz. Sahib Singh Gusain, and Ashok Purohit, and Marubhumi Consultants Private Limited, its Directors viz. Sushil Kumar Purohit, Bimal Kumar Joshi, and Enrich Consulting Private Limited, its Directors viz. Hiteshkumar Chhaganlal Kothari, Jayantilal K Thakker, and AHK Developers Private Limited, its Directors viz. Hiteshkumar Chhaganlal Kothari, Arti Hiteshkumar Kothari, and Sachin Kadam and B. B. Chitkara.

The M M court have not issued process or passed any order in this case.

2. Complaint against Rajiv Kashyap, Concord CHS Ltd. And Others

Mr. Ankush Ashok Gupta, has filed a Complaint under Section 420, 500, 405, 425, 427, 120 (B), read with 34 of Indian Penal Code against Rajiv Kashyap, Concord CHS Ltd. Ramesh Jani, Mira Chakravorthy, ABIDI, Manjula Mani, Mohid Zahoor, P. S. Chamankar and Asst. Engineer, K/West, MCGM Building proposal, Bandra (E) Mumbai with Addl. Commissioner of Police (EOW), Asst. Commissioner of Police and The Sr. Inspector of Police, Juhu Police Station, Vile Parle (w), Mumbai to register FIR against all these people.

a) Sushma Gupta's name appearing on www.watchoutinvestors.com

One of the promoters, Mrs. Sushma Gupta's, name appears on the website of www.watchoutinvestors.com in relation to loan default by Subhakti Textiles Pvt. Limited in relation to loan taken from Central Bank of India and later referred to DRT. The DRT has sold the assets to SICOM ARC Ltd.(SAL) and SAL has entered into an OTS with Subhakti Textiles Pvt. Ltd, and accordingly a sum of Rs. 225 lacs is payable to SAL. The Company/ Guarantors have paid Rs. 100 lacs till date to SAL.

Mrs. Sushma Gupta is one of the guarantors for the said loan.

b) Complaint under Section 138 of the Negotiable Instruments Act bearing C.C. No. 619/SS of 2006

M/s. Krishna Developers had filed a Complaint under Section 138 of the Negotiable Instruments Act bearing C.C. No. 619/SS of 2006 against accused Q's Fitness Studio and Mr. Ashok Gupta, proprietor of Q's Fitness Studio, in CMM 44th Court, Andheri at Mumbai. The said Complaint was filed due to non-encashment of two Cheques of Rs.23,000,00/- (Rupees Twenty Three Lakhs Each) collectively amounting to Rs.46,000,00/- (Rupees Forty Six Lakhs), which were returned unpaid by the Bankers of the Complainant, due to stop payment instructions issued by Q's Fitness Studio to their Bankers, Bank

of Baroda, Saki Naka Branch, Andheri (East), Mumbai. The court vide order dated March 24, 2014 has closed the evidence of accused due to case being of 2006 and there was no reason to keep the matter on same stage for long time and rejected the application of accused vide order dated July 16, 2014..

Mr. Ashok Gupta and Q's Fitness Studio has filed revision bearing Court case no. 904/2014 against above order in the Court of Sessions for Greater Bombay at Mumbai. The matter is pending for hearing.

c) Complaint against Ashok Gupta in the C.C. No. 100943/Cri. Rev. App. of 2012

The state and Mr. Jayesh Himmatlal Pandya, has filed a Complaint under Section 465, 467, 471, 472, 109 and 120 (B), of Indian Penal Code bearing *C.C. No. 100943/Criminal Revision Application of 2012* against Mr. Ashok Gupta in 51 Additional Sessions Judge Court, Mumbai. The said Complaint was filed in respect of dispute in respect of flat sold to Gupta family by joint venture company of Shiv Gupta and Hitesh Pandya.

d) Complaint against Ashok Gupta and others in the Long Cause suit No. 3067 of 1996

Minal Co-operative Housing Society Limited has filed Long Cause suit no. 3067 of 1996 in the Bombay City Civil Court against Ratnibai G. Poddar, Kailash G. Poddar, Ashok Gupta and other family members of Joint family for claiming land on which Gurukripa Building, 6 Dixit Road, Vile Parle E, Mumbai - 400057 is situated as their property.

Mr. Ashok Gupta has filed criminal case against original landlord Ratnibai G. Poddar (since deceased) and Mr. Kailash G. Poddar and others for wrongly conveying the above referred land in favour of Minal Co-operative Housing Society Limited.

The next date of hearing is September 11, 2014.

e) Complaint against Ketan Mehta and Ashok Gupta by Mr. Nithish Bangera

Mr. Nithish Bangera had filed complaint u/s. 500 read with 34 of Indian Penal Code bearing CC No. 1343/SS/2012 against Mr. Ketan Mehta, Employee of BSE and Mr. Ashok Gupta, Director of SVC Resources Ltd. with Ld. Metropolitan Magistrate's 68th Court, Borivali, Mumbai for publishing/posting article on BSE website alleging complainant of stealing statutory records and books of records of SVC Resources Ltd.

Mr. Ketan Mehta, had filed Criminal Revision Appeal no. 140 of 2013, against the order passed on the above referred complaint, in the Court of Session at Dindoshi (Borivali Division) at Goregaon Mumbai. The court vide order dated July 14, 2014 allowed the application and quashed the order allowing process against Mr. Ketan Mehta.

Mr. Ashok Gupta, has filed Criminal Revision Appeal no. 78 of 2014, challenging the order of issuance of process passed on the above referred complaint by 68th Metropolitan Magistrate's court at Borivali, in the Court of Session at Dindoshi (Borivali Division) at Goregaon Mumbai.

The next date of hearing is 2nd September 2014.

f) Complaint against Balaji International School in the S.C. Suit No. 2375 of 2009

Mr. Sunilkumar R. Kaniyampambal, has filed a suit no. *S.C. No. 2375 of 2009* against Balaji International School in the Bombay City Civil Court at Bombay (Borivali Division), Dindoshi Goregaon, Mumbai. The Complainant is claiming to be occupying the premises which is just adjacent to the premises of Balaji International School at CTS. No. 383B, Village Valnai, Taluka Borivali, Dist. Ani Anu Developers Pvt. Ltd. has received a notice u/s. 156 of the Income Tax Act, 1961 for AY 2007-08 dated March 15, 2013 issued by Assessing officer, ITO 4 (1) (3), Mumbai demanding a sum of Rs. 27,13,574/ as a penalty u/s. 271 (1) (c) of the Income Tax Act, 1961.

The Company has preferred an appeal before ITAT and the matter is pending.

h) Notice of Demand u/s. 156 of the Income Tax Act, 1961 relating to the Assessment Year 2011-12

SVC Resources Ltd. has received a notice u/s. 156 of the Income Tax Act, 1961 for AY 2011-12 dated March 24, 2014 issued by DCIT, Range 8(3), Mumbai demanding a sum of Rs. 16,84,500/ as a tax on the revision of income done by the Income Tax Department.

The Company has preferred an appeal before CIT (Appeals) and the matter is pending.

i) Letter from Office of the ROC, Maharashtra, Mumbai

SVC Resources Ltd. has received a letter dated April 01, 2013 forwarding the complaint received from Mr. Pramod Jain alleging that open offer was not given for change of management, the directors have defaulted u/s. 274 (1)(g), correct annual report not submitted to BSE and to ROC amongst others. The ROC has directed the Company to submit the point wise reply and documentary evidence wherever is necessary. There is no further communication.

j) Letter from Office of the ROC, Maharashtra, Mumbai

Santowin Corporation Ltd. has received a letter dated May 24, 2013 from the office of the ROC, Maharashtra, Mumbai forwarding the complaint received from Mr. Pramod Jain for alleged violations under the Companies Act, 1956, Listing Agreements etc. The ROC has directed the Company to submit the point wise reply and documentary evidence wherever is necessary. The ROC further sent the letter dated July 18, 2013 and August 2, 2013 demanding a reply on the above referred complaint.

Further, ROC vide order u/s. 234(3A) dated May 20, 2014 communicated to the Company to show cause why an action u/s. 234 (4) of the Companies Act, 1956 should not be initiated against the Company and its directors for non-furnishing of adequate reply to above referred letters.

The company has replied to RoC vide letter dated June 05, 2014 and requested for the personal hearing in the matter before proceeding with any action u/s 234(3A) & (4a).

k) Letter from Office of the ROC, Maharashtra, Mumbai

Santowin Corporation Ltd. has received a letter dated July 26, 2013 from the office of the ROC, Maharashtra, Mumbai forwarding the complaint received from Mr. Anil Kumar Poddar alleging violations under the Companies Act, 1956, Listing Agreements etc. The ROC has directed the Company to submit the point wise reply and documentary evidence wherever is necessary.

The Company has filed reply with CLB, Western Region Bench, Mumbai on October 18, 2013. There is no further communication/ actions from ROC.

l) Suit in the Court of Small Causes at Bombay in the matter of M/s. Raj Dadarkar & Associates vs. Power House Fitness Limited

M/s. Raj Dadarkar & Associates have filed suit against Power House Fitness Limited for eviction, injunction and recovery of arrears of compensation (Rent) of Rs. 1,18,98,000/-, in terms of Leave and

Licence Agreement and Business service Agreement, both dated November 20, 2008 for property situated at Shop no. 35, Sai Baba Shopping Center, Near Navjivan Society, Mumbai Central, Mumbai – 400008, in the Court of Small Causes at Bombay. The Power House Fitness Limited as contended the matter based on non-compliance of terms and conditions of Leave and Licence Agreement and Business service Agreement.

The Court has passed an interim order dated November 19, 2013, partially allowing the application, directing Power House Fitness Limited to deposit the arrears of compensation @ Rs. 150000 p.m. from September 2011 to November 2013 and further deposit Rs. 150000 p.m. till the decision of suit.

Power House Fitness Limited had preferred a Revision appeal no. 320 of 2013 with Appellate Bench in the same court against interim order dated November 19, 2013 and the appellate court has dismissed the revision application vide order dated February 01, 2014.

Aggrieved by these orders, Power House Fitness Limited has filed writ petition no. 6975 (st) of 2014 in the High Court of Judicature at Bombay, Civil Jurisdiction to quash and set aside the order dated February 01, 2014 and stay the implementation of interim order date November 19, 2013.

The next date of hearing is 11th October, 2014.

m) Two Director Identification Numbers (DIN) allotted to Mr. Ashok Gupta

Mr. Ashok Gupta, one of the Promoter group entity, was allotted two DINs viz. 00148126 and 00625213 in response to his application for DIN u/s. 266B of the Companies Act, 1956. MR. Ashok Gupta has applied to the Regional Director (Northern Region), Noida for cancellation of the DIN number 00625213 on November 30, 2013.

n) SEBI Letter dated June 28, 2013

SEBI had received complaint against Mr. Ashok Gupta alleging that Mr. Ashok Gupta and his connected entities have acquired the control of SVC Resources Limited during June 2006 to September 2006 without complying with the open offer requirements of SEBI (SAST) Regulations, 1997. It was further alleged that Mr. Gupta's family members acquired shares of Santowin Corporation Limited and takeover management control without complying with the open offer requirements of SEBI (SAST) Regulations, 1997. It was also alleged that pledge of shares of SVC Resources Limited and Santowin Corporation Limited was done without complying with disclosure requirements.

SEBI vide letter dated June 28, 2013 sought details of acquisition of shares of SVC Resources Limited by Mr. Ashok Gupta and his family members/ other related entities during June 2006 to September 2006 and Santowin Corporation Limited during March 2010 to June 2010 and the names of Companies where positions held as directors and comments of Mr. Gupta on the above referred allegations.

There is no further correspondence on the matter.

o) SEBI Letter dated September 26, 2012 and June 04, 2013

SEBI had received complaint from Dr. Savinder Singh against SVC Resources Limited alleging that its Directors Mr. Sunil B. Jain, Mr. Vishal Singh, Mr. Rajesh Kapoor and Mr. Mukesh Arora have acquired control of the Company in November 2011, without making any open offer.

SEBI vide letter dated September 26, 2012 sought comments from the Company on the issues raised in the above referred complaint. The Company had replied vide letter dated October 12, 2012 seeking more time to send detailed reply. SEBI vide letter dated June 04, 2013 again wrote to the Company to provide the comments on the issues raised in the above referred complaint and address the complaint forwarded through SCORES on August 30, 2012.

There is no further correspondence on the matter.

p) Income Tax Matter regarding Ashok Gupta HUF for for AY 2009-10 and AY 2010-11

There was a survey conducted by Income Tax Department on Ashok Gupta HUF (The Assessee) on January 31, 2012 and they had done certain addition to Ashok Gupta HUF Income as a part of assessment proceedings for AY 2009-10 and AY 2010-11. The total addition aggregated to approximately Rs. 7 crores. During the survey, they have taken custody of property documents relating to our gym situated at Concord, Juhu among other things and have kept with them as a security for recovery of the tax arising from addition to income. There is no physical attachment of the above referred property and our Company is still using the same. Ashok Gupta HUF, assessee and owner of the property has filed an appeal to contest the addition of Income with the Income Tax Appellate Tribunal for AY 2009-10 and with Commissioner of Income Tax Appellate AY 2010-11. Both the appeals are pending.

Pramod Jain, Sahib Singh Gusain, Lalit Gupta and Plus Corporate Ventures Private Limited, its Director viz. Sahib Singh Gusain, and Ashok Purohit, and Marubhumi Consultants Private Limited, its Directors viz. Sushil Kumar Purohit, Bimal Kumar Joshi, and Enrich Consulting Private Limited, its Directors viz. HiteshkumarChhaganlal Kothari, Jayantilal K Thakker, and AHK Developers Private Limited, its Directors viz. HiteshkumarChhaganlal Kothari, Arti Hiteshkumar Kothari, and Sachin Kadam and B. B. Chitkara.

The process is yet to be issued by M. M. Court.

2. Complaint u/s. 138 of Negotiable Instruments Act, 1881 bearing C.C. No. 1515/SS of 2014

Sri Balaji International School trust has issued notice u/s. 138 of the Negotiable Instrument Act, 1881 to Mr. PramodDubey for recovery of Rs. 1.50 crore being sale consideration paid towards purchase of plot of land. The cheque no. 104361 dated 30.12.2013 amounting to Rs. 1.50 croredrawn on Axis Bank, Borivali East branch, Mumbai, issued by Mr. PramodDubey was returned unpaid with remark “Funds Insufficient”.

Sri Balaji International School trust through its trustee Mr. Akshat Ashok Gupta has filed case bearing C.C. No. 1515/SS of 2014 for recovery of the above referred money.

The next date of hearing is 14th November, 2014.

3. Complaint for registering FIR u/s. 156(3) CPC against Anju Jalaj Batra and others

An applicant in the Net Public Category cannot make an application for that number of securities exceeding the number of securities offered to the public.

Application by Mutual Funds

As per the current regulations, the following restrictions are applicable for investments by mutual funds:

No mutual fund scheme shall invest more than 10% of its net asset value in the Equity Shares or equity related instruments of any Company provided that the limit of 10% shall not be applicable for investments in index funds or sector or industry specific funds. No mutual fund under all its schemes should own more than 10% of any Company's paid up share capital carrying voting rights.

In case of a Mutual Fund, a separate Application can be made in respect of each scheme of the Mutual Fund registered with SEBI and such Applications in respect of more than one scheme of the Mutual Fund will not be treated as multiple Applications provided that the Applications clearly indicate the scheme concerned for which the Application has been made.

Applications by Eligible NRIs/FII's on Repatriation Basis

Application Forms have been made available for Eligible NRIs at our registered Office.

Eligible NRI applicants may please note that only such applications as are accompanied by payment in free foreign exchange shall be considered for Allotment. The Eligible NRIs who intend to make payment through Non Resident Ordinary (NRO) accounts shall use the form meant for Resident Indians.

Under the Foreign Exchange Management Act, 1999 (FEMA) general permission is granted to the companies vide notification no. FEMA/20/2000 RB dated 03/05/2000 to issue securities to NRI's subject to the terms and conditions stipulated therein. The Companies are required to file the declaration in the prescribed form to the concerned Regional Office of RBI within 30 days from the date of issue of shares for allotment to NRI's on repatriation basis.

Allotment of Equity Shares to Non Resident Indians shall be subject to the prevailing Reserve Bank of India Guidelines. Sale proceeds of such investments in Equity Shares will be allowed to be repatriated along with the income thereon subject to permission of the RBI and subject to the Indian Tax Laws and regulations and any other applicable laws.

The Company does not require approvals from FIPB or RBI for the Transfer of Equity Shares in the issue to eligible NRI's, FII's, Foreign Venture Capital Investors registered with SEBI and multilateral and bilateral development financial institutions.

As per the current regulations, the following restrictions are applicable for investments by FIIs:

The issue of Equity Shares to a single FII should not exceed 10% of our post Issue issued capital. In respect of an FII investing in our equity shares on behalf of its sub accounts, the investment on behalf of each sub account shall not exceed 10% of our total issued capital or 5% of our total issued capital in case such sub account is a foreign corporate or an individual.

In accordance with the foreign investment limits, the aggregate FII holding in our Company cannot exceed 24% of our total issued capital. With the approval of the board and the shareholders by way of a special resolution, the aggregate FII holding can go up to 100%. However, as on this date, no such resolution has been recommended to the shareholders of the Company for adoption.

Subject to compliance with all applicable Indian laws, rules, regulations, guidelines and approvals in terms of regulation 15A(1) of the Securities Exchange Board of India (Foreign Institutional Investors) Regulations 1995, as amended, an FII may issue, deal or hold, off shore derivative instruments such as participatory notes, equity linked notes or any other similar instruments against underlying securities listed or proposed to be listed in any stock exchange in India only in favour of those entities which are regulated by any relevant regulatory authorities in the countries of their incorporation or establishment subject to compliance of "Know Your Client" requirements. An FII shall also ensure that no further downstream issue or transfer of any instrument referred to hereinabove is made to any person other than a regulated entity.

In case of FII's in NRI/FII Portion, number of Equity Shares applied shall not exceed issue size.

Applications by SEBI registered Venture Capital Funds and Foreign Venture Capital Investors

As per the current regulations, the following restrictions are applicable for SEBI Registered Venture Capital Funds and Foreign Venture Capital Investors:

The SEBI (Venture Capital) Regulations, 1996 and the SEBI (Foreign Venture Capital Investor) Regulations, 2000 prescribe investment restrictions on venture capital funds and foreign venture capital investors registered with SEBI.

Accordingly, whilst the holding by any individual venture capital fund registered with SEBI in one Company should not exceed 25% of the corpus of the venture capital fund, a Foreign Venture Capital Investor can invest its entire funds committed for investments into India in one Company. Further, Venture Capital Funds and Foreign Venture Capital Investors can invest only up to 33.33% of the investible funds by way of subscription to an initial public offer.

The above information is given for the benefit of the Applicants. The Company and the LM are not liable for any amendments or modification or changes in applicable laws or regulations, which may occur after the date of the Prospectus. Applicants are advised to make their independent investigations and ensure that the number of Equity Shares applied for do not exceed the applicable limits under laws or regulations.

MAXIMUM AND MINIMUM APPLICATION SIZE

(a) For Retail Individual Applicants

The Application must be for a 4,000 Equity Shares so as to ensure that the Application Price payable by the Applicant does not exceed ₹ 2,00,000. In case of revision of Applications, the Retail Individual Applicants have to ensure that the Application Price does not exceed ₹ 2,00,000.

(b) For Other Applicants (Non Institutional Applicants and QIBs):

The Application must be for a minimum of such number of Equity Shares such that the Application Amount exceeds ₹ 200,000 and in multiples of 4,000 Equity Shares thereafter. An Application cannot be submitted for more than the Issue Size. However, the maximum Application by a QIB investor should not exceed the

investment limits prescribed for them by applicable laws. Under existing SEBI Regulations, Non Institutional Applicants and QIB Applicants cannot withdraw its Application after the Issue Closing Date and is required to pay 100% QIB Margin upon submission of Application.

Applicants are advised to ensure that any single Application from them does not exceed the investment limits or maximum number of Equity Shares that can be held by them under applicable law or regulation or as specified in the Prospectus.

Applications under Power of Attorney

In case of Applications made pursuant to a power of attorney or by limited companies, corporate bodies, registered societies, a certified copy of the power of attorney or the relevant resolution or authority, as the case may be, along with a certified copy of the Memorandum of Association and Articles of Association and/ or bye laws must be lodged along with the Application Form. Failing this, the Company reserves the right to accept or reject any Application in whole or in part, in either case, without assigning any reason thereof.

In case of Applications made pursuant to a power of attorney by FIIs, a certified copy of the power of attorney or the relevant resolution or authority, as the case may be, along with a certified copy of their SEBI registration certificate must be lodged along with the Application Form. Failing this, the Company reserves the right to accept or reject any Application in whole or in part, in either case, without assigning any reason thereof.

In case of Applications made pursuant to a power of attorney by Mutual Funds, a certified copy of the power of attorney or the relevant resolution or authority, as the case may be, along with the certified copy of their SEBI registration certificate must be lodged along with the Application Form. Failing this, the Company reserves the right to accept or reject any Application in whole or in part, in either case, without assigning any reason thereof.

In case of Applications made by insurance companies registered with the Insurance Regulatory and Development Authority, a certified copy of certificate of registration issued by Insurance Regulatory and Development Authority must be lodged along with the Application Form. Failing this, the Company reserves the right to accept or reject any Application in whole or in part, in either case, without assigning any reason thereof.

In case of Applications made by provident funds with minimum corpus of ₹ 25 crore (subject to applicable law) and pension funds with minimum corpus of ₹ 25 crore, a certified copy of certificate from a chartered accountant certifying the corpus of the provident fund/ pension fund must be lodged along with the Application Form. Failing this, the Company reserves the right to accept or reject any Application in whole or in part, in either case, without assigning any reason thereof.

The Company in its absolute discretion, reserve the right to relax the above condition of simultaneous lodging of the power of attorney along with the Application Form, subject to such terms and conditions that the Company and the LM may deem fit.

Information for the Applicants:

- a) Our Company will file the Prospectus with the RoC at least 3 (three) days before the Issue Opening Date.
- b) The LM will circulate copies of the Prospectus along with the Application Form to potential investors.
- c) Any investor (who is eligible to invest in our Equity Shares) who would like to obtain the Prospectus and/ or the Application Form can obtain the same from our registered office or from the corporate office of the LM.
- d) Applicants who are interested in subscribing for the Equity Shares should approach the LM or their authorized agent(s) to register their Applications.
- e) Applications made in the Name of Minors and/or their nominees shall not be accepted.

- f) Applicants are requested to mention the application form number on the reverse of the instrument to avoid misuse of instrument submitted along with the application for shares. Applicants are advised in their own interest, to indicate the name of the bank and the savings or current a/c no in the application form. In case of refund, the refund order will indicate these details after the name of the payee. The refund order will be sent directly to the payee's address.

Instructions for Completing the Application Form

The Applications should be submitted on the prescribed Application Form and in BLOCK LETTERS in ENGLISH only in accordance with the instructions contained herein and in the Application Form. Applications not so made are liable to be rejected. ASBA Application Forms should bear the stamp of the SCSB's. ASBA Application Forms, which do not bear the stamp of the SCSB, will be rejected.

Applicants residing at places where the designated branches of the Banker to the Issue are not located may submit/mail their applications at their sole risk along with Demand Draft payable at Mumbai.

Applicant's Depository Account and Bank Details

Applicants should note that on the basis of name of the Applicants, Depository Participant's name, Depository Participant Identification number and Beneficiary Account Number provided by them in the Application Form, the Registrar to the Issue will obtain from the Depository the demographic details including address, Applicants bank account details, MICR code and occupation (hereinafter referred to as 'Demographic Details'). These Bank Account details would be used for giving refunds to the Applicants. Hence, Applicants are advised to immediately update their Bank Account details as appearing on the records of the depository participant. Please note that failure to do so could result in delays in dispatch/ credit of refunds to Applicants at the Applicants sole risk and neither the LM or the Registrar or the Escrow Collection Banks or the SCSB nor the Company shall have any responsibility and undertake any liability for the same. Hence, Applicants should carefully fill in their Depository Account details in the Application Form.

These Demographic Details would be used for all correspondence with the Applicants including mailing of the CANs / Allocation Advice and printing of Bank particulars on the refund orders or for refunds through electronic transfer of funds, as applicable. The Demographic Details given by Applicants in the Application Form would not be used for any other purpose by the Registrar to the Issue.

By signing the Application Form, the Applicant would be deemed to have authorized the depositories to provide, upon request, to the Registrar to the Issue, the required Demographic Details as available on its records.

BASIS OF ALLOTMENT

Allotment will be made in consultation with SME Platform of BSE (The Designated Stock Exchange). In the event of oversubscription, the allotment will be made on a proportionate basis in marketable lots as set forth here:

1. The total number of Shares to be allocated to each category as a whole shall be arrived at on a proportionate basis i.e. the total number of Shares applied for in that category multiplied by the inverse of the over subscription ratio (number of applicants in the category x number of Shares applied for).
2. The number of Shares to be allocated to the successful applicants will be arrived at on a proportionate basis in marketable lots (i.e. Total number of Shares applied for into the inverse of the over subscription ratio).
3. For applications where the proportionate allotment works out to less than 4,000 equity shares the allotment will be made as follows:
 - a) Each successful applicant shall be allotted 4,000 equity shares; and
 - b) The successful applicants out of the total applicants for that category shall be determined by the drawal of lots in such a manner that the total number of Shares allotted in that category is equal to the number of Shares worked out as per (2) above.

If as a result of the process of rounding off to the lower nearest multiple of 4,000 equity shares, results in the actual allotment being higher than the shares offered, the final allotment may be higher at the sole discretion of the Board of Directors, upto 110% of the size of the offer specified under the Capital Structure mentioned in the Prospectus.
6. The above proportionate allotment of shares in an Issue that is oversubscribed shall be subject to the reservation for small individual applicants as described below
 - a) A minimum of 50% of the net offer of shares to the Public shall initially be made available for allotment to retail individual investors as the case may be.
 - b) The balance net offer of shares to the public shall be made available for allotment to a) individual applicants other than retails individual investors and b) other investors, including Corporate Bodies/ Institutions irrespective of number of shares applied for.
 - c) The unsubscribed portion of the net offer to any one of the categories specified in (a) or (b) shall/may be made available for allocation to applicants in the other category, if so required.

However, if the retail individual investor category is entitled to more than fifty per cent. on proportionate basis, the retail individual investors shall be allocated that higher percentage.

'Retail Individual Investor' means an investor who applies for shares of value of not more than ₹ 2,00,000/ . Investors may note that in case of over subscription allotment shall be on proportionate basis and will be finalized in consultation with SME Platform of BSE.

The Executive Director / Managing Director of the SME Platform of BSE, Designated Stock Exchange in addition to Lead Merchant Banker and Registrar to the Public Issue shall be responsible to ensure that the basis of allotment is finalized in a fair and proper manner in accordance with the SEBI (ICDR) Regulations, 2009.

REFUNDS:

In case of Applicants receiving refunds through electronic transfer of funds, delivery of refund orders/ allocation advice/ CANs may get delayed if the same once sent to the address obtained from the depositories are returned undelivered. In such an event, the address and other details given by the Applicant in the Application Form would be used only to ensure dispatch of refund orders. Please note that any such delay shall be at the Applicants sole risk and neither the Company, the Registrar, Escrow Collection Bank(s) nor the LM shall be liable to compensate the Applicant for any losses caused to the Applicant due to any such delay or liable to pay any interest for such delay.

In case no corresponding record is available with the Depositories, which matches three parameters, namely, names of the Applicants (including the order of names of joint holders), the Depository Participant's identity (DP ID) and the beneficiary's identity, then such Applications are liable to be rejected.

The Company in its absolute discretion, reserves the right to permit the holder of the power of attorney to request the Registrar that for the purpose of printing particulars on the refund order and mailing of the refund order/ CANs/ allocation advice/ refunds through electronic transfer of funds, the Demographic Details given on the Application Form should be used (and not those obtained from the Depository of the Applicant). In such cases, the Registrar shall use Demographic Details as given in the Application Form instead of those obtained from the depositories.

Refunds, dividends and other distributions, if any, will be payable in Indian Rupees only and net of bank charges and/ or commission. In case of Applicants who remit money through Indian Rupee drafts purchased abroad, such payments in Indian Rupees will be converted into US Dollars or any other freely convertible currency as may be permitted by the RBI at the rate of exchange prevailing at the time of remittance and will be dispatched by registered post or if the Applicants so desire, will be credited to their NRE accounts, details of which should be furnished in the space provided for this purpose in the Application Form. The Company will not be responsible for loss, if any, incurred by the Applicant on account of conversion of foreign currency.

As per the RBI regulations, OCBs are not permitted to participate in the Issue.

There is no reservation for Non Residents, NRIs, FIIs and foreign venture capital funds and all Non Residents, NRI, FII and Foreign Venture Capital Funds applicants will be treated on the same basis with other categories for the purpose of allocation.

TERMS OF PAYMENT / PAYMENT INSTRUCTIONS

The entire issue price of ₹ 30 per share is payable on application. In case of allotment of lesser number of Equity shares than the number applied, The Company shall refund the excess amount paid on Application to the Applicants.

Payments should be made by cheque, or demand draft drawn on any Bank (including a Co operative Bank), which is situated at, and is a member of or sub member of the bankers' clearing house located at the centre where the Application Form is submitted. Outstation cheques/ bank drafts drawn on banks not participating in the clearing process will not be accepted and applications accompanied by such cheques or bank drafts are liable to be rejected.

Cash/ Stockinvest/ Money Orders/ Postal orders will not be accepted.

A separate Cheque or Bank Draft should accompany each application form. Applicants should write the Share Application Number on the back of the Cheque /Draft. Outstation Cheques will not be accepted and applications accompanied by such cheques drawn on outstation banks are liable for rejection. Money Orders / Postal Notes will not be accepted.

Each Applicant shall draw a cheque or demand draft for the amount payable on the Application and/ or on allocation/ Allotment as per the following terms:

Where an Applicant has been allocated a lesser number of Equity Shares than the Applicant has applied for, the excess amount, if any, paid on Application, after adjustment towards the balance amount payable by the Pay In Date on the Equity Shares allocated will be refunded to the Applicant from the Refund Account.
4. On the Designated Date and no later than 15 days from the Issue Closing Date, the Escrow Collection Bank shall also refund all amounts payable to unsuccessful Applicants and also the excess amount paid on Application, if any, after adjusting for allocation / Allotment to the Applicants.

Payment by Stock invest

In terms of the Reserve Bank of India Circular No. DBOD No. FSC BC 42/ 24.47.00/ 2003 04 dated November 5, 2003; the option to use the stock invest instrument in lieu of cheques or bank drafts for payment of Application money has been withdrawn. Hence, payment through stock invest would not be accepted in this Issue.

GENERAL INSTRUCTIONS

Do's:

- Check if you are eligible to apply;
- Read all the instructions carefully and complete the applicable Application Form;
- Ensure that the details about Depository Participant and Beneficiary Account are correct as Allotment of Equity Shares will be in the dematerialized form only;
- Each of the Applicants should mention their Permanent Account Number (PAN) allotted under the Income Tax Act, 1961;

Don'ts:

Joint Applications in the case of Individuals

Applications may be made in single or joint names (not more than three). In the case of joint Applications, all payments will be made out in favour of the Applicant whose name appears first in the Application Form or Revision Form. All communications will be addressed to the First Applicant and will be dispatched to his or her address as per the Demographic Details received from the Depository.

Multiple Applications

An Applicant should submit only one Application (and not more than one) for the total number of Equity Shares required. Two or more Applications will be deemed to be multiple Applications if the sole or First Applicant is one and the same.

In this regard, the procedures which would be followed by the Registrar to the Issue to detect multiple applications are given below:

All applications are electronically strung on first name, address (1st line) and applicant's status. Further, these applications are electronically matched for common first name and address and if matched, these are checked manually for age, signature and father/ husband's name to determine if they are multiple applications

- i. Applications which do not qualify as multiple applications as per above procedure are further checked for common DP ID/ beneficiary ID. In case of applications with common DP ID/ beneficiary ID, are manually checked to eliminate possibility of data entry error to determine if they are multiple applications.
- ii. Applications which do not qualify as multiple applications as per above procedure are further checked for common PAN. All such matched applications with common PAN are manually checked to eliminate possibility of data capture error to determine if they are multiple applications.

No separate applications for demat and physical is to be made. If such applications are made, the applications for physical shares will be treated as multiple applications and rejected accordingly.

In case of a mutual fund, a separate Application can be made in respect of each scheme of the mutual fund registered with SEBI and such Applications in respect of more than one scheme of the mutual fund will not be treated as multiple Applications provided that the Applications clearly indicate the scheme concerned for which the Application has been made.

In cases where there are more than 20 valid applications having a common address, such shares will be kept in abeyance, post allotment and released on confirmation of “know your client” norms by the depositories. The Company reserves the right to reject, in our absolute discretion, all or any multiple Applications in any or all categories.

Permanent Account Number or PAN

Pursuant to the circular MRD/DoP/Circ 05/2007 dated April 27, 2007, SEBI has mandated Permanent Account Number (“PAN”) to be the sole identification number for all participants transacting in the securities market, irrespective of the amount of the transaction w.e.f. July 2, 2007. Each of the Applicants should mention his/her PAN allotted under the IT Act. **Applications without this information will be considered incomplete and are liable to be rejected.** It is to be specifically noted that Applicants should not submit the GIR number instead of the PAN, as the Application is liable to be rejected on this ground.

RIGHT TO REJECT APPLICATIONS

In case of QIB Applicants, the Company in consultation with the LM may reject Applications provided that the reasons for rejecting the same shall be provided to such Applicant in writing. In case of Non Institutional Applicants, Retail Individual Applicants who applied, the Company has a right to reject Applications based on technical grounds.

Grounds for Rejections

Applicants are advised to note that Applications are liable to be rejected inter alia on the following technical grounds:

- Amount paid does not tally with the amount payable for the value of Equity Shares applied for;
- In case of partnership firms, Equity Shares may be registered in the names of the individual partners and no firm as such shall be entitled to apply;
- Application by persons not competent to contract under the Indian Contract Act, 1872 including minors, insane persons;
- PAN not mentioned in the Application Form;
- GIR number furnished instead of PAN;
- Applications for lower number of Equity Shares than specified for that category of investors;
- Applications at a price other than the Fixed Price of The Issue;
- Applications for number of Equity Shares which are not in multiples of 4,000;
- Category not ticked;
- Multiple Applications as defined in the Prospectus;
- In case of Application under power of attorney or by limited companies, corporate, trust etc., where relevant documents are not submitted;
- Applications accompanied by Stock invest/ money order/ postal order/ cash;
- Signature of sole Applicant is missing;

- Application Forms are not delivered by the Applicant within the time prescribed as per the Application Forms, Issue Opening Date advertisement and the Prospectus and as per the instructions in the Prospectus and the Application Forms;
- In case no corresponding record is available with the Depositories that matches three parameters namely, names of the Applicants (including the order of names of joint holders), the Depository Participant's identity (DP ID) and the beneficiary's account number;
- Applications for amounts greater than the maximum permissible amounts prescribed by the regulations;
- Applications where clear funds are not available in the Escrow Account as per the final certificate from the Escrow Collection Bank(s);
- Applications by OCBs;
- Applications not duly signed by the sole;
- Applications by any persons outside India if not in compliance with applicable foreign and Indian laws;
- Applications that do not comply with the securities laws of their respective jurisdictions are liable to be rejected;
- Applications by persons prohibited from buying, selling or dealing in the shares directly or indirectly by SEBI or any other regulatory authority;
- Applications by persons who are not eligible to acquire Equity Shares of the Company in terms of all applicable laws, rules, regulations, guidelines, and approvals;
- Applications or revisions thereof by QIB Applicants, Non Institutional Applicants where the Application Amount is in excess of ₹ 2,00,000, received after 5.00 pm on the Issue Closing Date;

Impersonation

Attention of the Applicants is specifically drawn to the provisions of sub-section (1) of Section 38 of the Companies Act, 2013 which is reproduced below:

“Any person who –

- (d) makes or abets making of an application in a fictitious name to a company for acquiring, or subscribing for, its securities, or*
- (e) makes or abets making of multiple applications to a company in different names or in different combinations of his name or surname for acquiring or subscribing for its securities; or*
- (f) otherwise induces directly or indirectly a company to allot, or register any transfer of, securities to him, or to any other person in a fictitious name, shall be liable for action under section 447.”*

The liability prescribed under Section 447 of the Companies Act, 2013, includes imprisonment for a term of not less than six months extending up to ten years (provided that where the fraud involves public interest, such term shall not be less than three years) and fine of an amount not less than the amount involved in the fraud, extending up to three times of such amount.

Signing of Underwriting Agreement

Vide an Underwriting agreement dated July 1, 2014 this issue is 100% Underwritten.

Filing of the Prospectus with the RoC

The Company will file a copy of the Prospectus with the RoC in terms of Section 26 of the Companies Act, 2013.

Pre-Issue Advertisement

Subject to Section 30 of the Companies Act, 2013, the Company shall, after registering the Prospectus with the RoC, publish a pre-Issue advertisement, in the form prescribed by the SEBI Regulations, in one widely circulated English language national daily newspaper and one widely circulated Hindi language national daily newspaper with wide circulation.

Designated Date and Allotment of Equity Shares

The Company will issue and dispatch letters of allotment/ securities certificates and/ or letters of regret along with refund order or credit the allotted securities to the respective beneficiary accounts, if any within a period of 12 days of the Issue Closing Date.

In case the Company issues Letters of allotment, the corresponding Security Certificates will be kept ready within three months from the date of allotment thereof or such extended time as may be approved by the Company Law Board under Section 56 of the Companies Act, 2013 or other applicable provisions, if any. Allottees are requested to preserve such Letters of Allotment, which would be exchanged later for the Security Certificates.

ASBA Process

A Resident Retail Individual Investor shall submit his Application through an Application Form, either in physical or electronic mode, to the SCSB with whom the bank account of the ASBA Applicant or bank account utilized by the ASBA Applicant (“**ASBA Account**”) is maintained. The SCSB shall block an amount equal to the Application Amount in the bank account specified in the ASBA

Application Form, physical or electronic, on the basis of an authorization to this effect given by the account holder at the time of submitting the Application.

RESTRICTIONS ON FOREIGN OWNERSHIP OF INDIAN SECURITIES

Foreign investment in Indian securities is regulated primarily by the FEMA and the policy prescribed by the Department of Industrial Policy and Promotion, Government of India through Consolidated FDI Policy Circular of 2014 with effect from April 17, 2014 (“**FDI Policy**”). While the FDI Policy prescribes the limits and the conditions subject to which foreign investment can be made in different sectors of the Indian economy, FEMA regulates the precise manner in which such investment may be made. Under the FDI Policy, unless specifically restricted, foreign investment is freely permitted in all sectors of Indian economy up to any extent and without any prior approvals, but the foreign investor is required to follow certain prescribed procedures for making such investment. The Government bodies responsible for granting foreign investment approvals are FIPB and the RBI.

In terms of the Consolidated FDI policy (effective from April 17, 2014), issued by the Department of Industrial Policy and Promotion, 100% foreign direct investment in the Company is permitted.

Subscription by foreign investors (NRIs/FIIs)

FIIs are permitted to subscribe to shares of an Indian company in a public offer without the prior approval of the RBI, so long as the price of the equity shares to be issued is not less than the price at which the equity shares are issued to residents.

The transfer of shares between an Indian resident and a non-resident does not require the prior approval of the FIPB or the RBI, provided that (i) the activities of the investee company are under the automatic route under the FDI Policy and transfer does not attract the provisions of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 (ii) the non-resident shareholding is within the sectoral limits under the FDI Policy; and (iii) the pricing is in accordance with the guidelines prescribed by SEBI/ RBI.

As per the existing policy of the Government of India, OCBs cannot participate in this Issue.

The Equity Shares have not been and will not be registered, listed or otherwise qualified in any other jurisdiction outside India and may not be offered or sold, and Applications may not be made by persons in any such jurisdiction, except in compliance with the applicable laws of such jurisdiction.

The above information is given for the benefit of the Applicants. Our Company and the Lead Manager are not liable for any amendments or modification or changes in applicable laws or regulations, which may occur after the date of the Prospectus. Applicants are advised to make their independent investigations and ensure that the number of Equity Shares applied for do not exceed the applicable limits under laws or regulations.

Certain defined terms used in the Articles of Association are set forth below. All other defined terms used in this section have the meaning given to them in the Articles of Association.

The Authorised capital of our Company is ₹ 7,00,00,000 divided into ₹ 70,00,000 Equity Shares of ₹ 10 each.
